INTRODUCTION

Through the Covid-19 vaccination program, all people everywhere are being asked to participate in the largest medical experiment in human history.

According to the World Bank and other authorities and institutions, the Covid-19 “crisis” will be escalating over the next few years. In fact, World Health Organization (WHO) official Dr Michael Ryan has declared the coronavirus “may never go away”. That’s a warning from the top (#1). Thus it should be no surprise that mutated strains of Covid-19 are already being reported in the news (#1.1). This situation, of course, will have an unprecedented impact on all people globally.

This document encapsulates 13 months’ research on events with Covid-19. Source notes are in brackets. Must-see sources are highlighted in red, some of which are listed in Chapter 9. Please note that new information is coming to hand every day. Nevertheless, this document will provide a foundation for what has happened so far as well as a forecast for where we are heading. Also, the video links’ document contains many excellent sources for others to further their investigations. *Here I examine the Who, What, When, Where, Why and How of the Covid-19 narrative.*

First up, I would like to draw attention to an exceptional resource I will be referring to often in this document. It is titled **Global Report 2019-nCoV Summary of Facts** (#1.2) and it has been compiled by a group of **German doctors** with affirming signatories of thousands of scientists, medical doctors and medical experts from around the world. Here is the link to the German doctors’ website (#2). These doctors, who claim the mainstream Covid-19 narrative is “a scam” (because it is no different to any other coronavirus), originally called themselves the **Extra-parliamentary Corona Investigation Committee (and Partners)** (#3.1, #3.2). However, when it became clear that the governments of the world were backing the Covid “scamdemic”, these doctors joined with other concerned professionals and renamed themselves **World Freedom Alliance** (#3.3).

Another similar group is **Doctors for the Truth** in Spain, led by **Dr Natalia Prego Cancelo** and **Dr Angel Luis Valdepeñas**. Totalling around 600, these doctors have made a direct connection with the Extra-parliamentary Commission of doctors from Germany, as well as an epidemiologists’ group from Argentina, and doctors from the US and Argentina. The Doctors for the Truth agree that:

- Coronavirus victims did not outnumber last year’s seasonal flu deaths.
- Figures were exaggerated by altering medical protocols.
- The confinement of the healthy and the forced use of masks have no scientific basis.
- The disease known as Covid-19 does not have a single infectious pattern, but a combination of them (#4).

I would also like to set the frame, upfront, with an important statement by **Dr Roger Hodkinson**, a Covid-19 expert who, like the German doctors mentioned above, also has a counter narrative to what the press and politicians are telling us. In desperation, Dr Hodkinson addresses the Chairman of

the Community and Public Service Committee in Canada in November 2020. The conversation was secretly recorded and leaked to the independent media. He says:

“There is utterly unfounded public hysteria driven by the media and politicians. It is outrageous. This is the greatest hoax ever perpetrated on an unsuspecting public. There is absolutely nothing that can be done to contain this virus other than protecting older more vulnerable people. It should be thought of nothing more than a bad flu season...”

To prove he is not a “quack” (his words), Dr Hodgkinson begins by stating his credentials: “I am a medical specialist in pathology, which includes virology. I was trained at Cambridge University in the UK and was the President of the Pathology section of the Medical Association. Previously I was an assistant professor in the Faculty of Medicine, mostly teaching. I was also the Chairman of the Royal College of Physicians of Canada Examination Committee and Pathology in Ottawa” (#5.1).

A great deal of mystery surrounds this virus. Some doctors say it is similar to, and no more dangerous than, the regular flu. There are those who believe it is a naturally occurring virus and others say it has been biologically engineered, the latter divided between whether it escaped from a lab by accident or was released on purpose. Other doctors report that Covid-19 patients do not present with typical Acute Respiratory Distress Syndrome (ARDS) symptoms but symptoms similar to altitude sickness.

Many doctors who have been working exclusively with Covid-19 patients are mystified as to why certain disadvantage communities have suffered more than others, with Blacks, Asians and Hispanics (and the elderly) being the most affected by the pandemic. And in Europe, hundreds of doctors are convinced there is some “crossover toxic pattern” between electromagnetic contamination of 5G and the influence of previous influenza vaccinations (e.g. H1N1). Many medical experts and lawyers are lobbying their governments to investigate these leads.

Regardless of their queries, what has infuriated these health professionals most is that governments and health authorities everywhere are keeping the door firmly shut on discussing the matter while aggressively pushing highly unpredictable experimental vaccine programs on their citizens. Why is this happening, these doctors ask, when well-established, easy to obtain and inexpensive drugs, which have proven to be safe and 100 per cent effective in preventing and treating Covid-19, are being ignored and shunted aside for the sake of a dogmatic narrative that must not be questioned?

I will now provide a round-up of what I consider to be significant events around the world since Covid-19 “exploded” in the mainstream news. **By the end of this document, it should be evident there are currently TWO great deceptions rapidly emerging on the world scene.** And although they appear to be in opposition, they are in fact being used by the god of this world to bring about a very specific outcome, which lines up with Bible warnings about the last days.

But first, here is some perspective on the dangers of Covid. The WHO claimed in February 2021 that 2.46 million people have died worldwide from Covid. Now if we accept that number as true (ignoring the fact that influenza and pneumonia deaths have been “unusually low” during the same period, and doctors have been forced to manipulate death certificates stating Covid is the primary cause of death), let us compare it with another statistic. **Each year 50 million people contract sepsis with 11 MILLION PEOPLE DYING FROM IT. In fact, more people die of sepsis than breast, bowel and pancreatic cancer together – YET NO ONE EVER HEARS ABOUT THIS!** (#5.2).

Postscript January 2022: Too much has happened (since I compiled this information in April 2021) for me to update this document. However, it still provides a solid foundation to later developments.

THE TRUTH ABOUT COVID-19

The Highwire's Del Bigtree interviews Dr Naomi Wolf, author of The End of America and former Clinton Advisor. She is also CEO of tech company dailyclout.io. CHAPTER 1: THOUSANDS OF MEDICAL PROFESSIONALS CHALLENGING MAINSTREAM COVID-19 NARRATIVE

The UK's Operation Moonshot

Few people know that a leaked document in September (2020) to the British Medical Journal stated that the UK would be launching Operation Moonshot in 2021. This governmental operation has allocated *£100 billion* to roll out a Covid-19 PCR detection program to test 10 million people every day, covering the whole population in one week. This will continue weekly, with the costs escalating! And this looks like becoming the Covid-testing model for other nations as well. This is in spite of the fact that “the overall lethality of Covid-19 is about 0.1% to 0.3% and thus in the range of a severe influenza”. Also, as the German doctors tell us, **“Up to 90% of PCR tests are generating false positives”** (refer to Global Report).

News Station Fox 35 had a similar report when they investigated 22 labs that had provided a 100% positivity rate in PCR testing, meaning every single person tested positive for the virus. Another lab reported 98%. On investigation, rates were more like 6%-9% positives (#5.3).

The **British Medical Journal** (BMJ) has responded to the UK's Operation Moonshot in its September 22, 2020, issue with the headline: ‘Operation Moonshot proposals are scientifically unsound’. The BMJ article goes on to report that the polymerase chain reaction (PCR) swab test “is not a test for infectiousness ... If PCR is used to identify cases through mass testing of healthy people, it will deliver positive results in individuals with previous resolved infections, new infections, and potential re-infections, as well as false positives in people genuinely not harbouring the virus” (#6.1; #6.2).

In fact, scientists and physicians have raised concerns for many months of an over-reliance on, and a misuse of, the **PCR test as a diagnostic tool, since it can't differentiate between a live infectious virus and an inactivated virus fragment that is not infectious**. Additionally, the high-cycle threshold values of most PCR tests—at an amplification of 40 cycles or higher—increases the risk of false positives. This is because the greater the amplification is of genetic material the more chance there is to detect a smaller viral load and that person is less likely to be infectious. In January 2021, the WHO finally updated its guidelines for PCR testing to take account of these and other factors in PCR testing (#6.3). The independent Off Guardian new reports:

“Even Dr Anthony Fauci has publicly admitted that a cycle threshold over 35 is going to be detecting ‘dead nucleotides’, not a living virus. Despite all this, it is known that many labs around the world have been using PCR tests with CT values over 35, even into the low 40s. So why has the WHO finally decided to say this is wrong? What reason could they have for finally choosing to recognise this simple reality? The answer to that is potentially shockingly cynical: **We have a vaccine now. We don't need false positives anymore**” (#6.4).

These facts are supported by **Dr Kary Mullis**, who won a Nobel Prize in Chemistry for inventing the PCR test. Mullis died four months before Covid-19 appeared. Nevertheless, he explains that his test was not designed to diagnose viruses: **“The PCR is a process. It cannot be used to diagnose an infectious disease. What the PCR allows you to do is take something [genetic material] that is miniscule, amplify it and then discuss what you see. It is not a test for anything and should not be used as a diagnostic test”** (#7.1).

Robert F Kennedy called virologist Dr Judy Mikovits “among the most skilled scientists of her generation”. Speaking about the worthlessness of PCR testing, she said, “To get the sequence of a

disease you isolate it from a person with the disease. ... The CDC [Centers for Disease Control] admitted back in July 2020 that the sequences they were using on the PCR test were of a synthetic virus. They did not have a complete sequence of a disease-causing SAR-CoV-2 from a human being, only from monkey cells. This is because the sequences from the coronaviruses have never been able to be isolated from a human with the disease and shown to be infectious and transmissible” (#7.2). In other words, the PCR test is not even testing for the human strain of Covid-19 anyway.

Dr Elke de Klerk, founder of **Doctors for Truth in The Netherlands**, has stated that the regular press in the Netherlands is finally publishing the fact that PCR testing cannot be used to diagnose Covid-19 (#8). Nevertheless, as of November 2020, more than 85 million test kits had been sold worldwide generating \$13 billion income for its manufacturers.

The CDC “Owns” Covid-19

Along with the German doctors’ Global Report, another exceptionally informative resource is the US film **Plandemic 2 Indoctrination** (#9.1), which exposes Covid-19 as a criminal operation organised by the world’s elites. It explains how the Centers for Disease Control in the US (CDC) holds the patent for the Covid-19 test kits as well as for the disease itself. This is illegal, because no one can patent a natural virus, unless it is not natural but genetically modified, which is also illegal. This patent means the CDC has the ability to control who is authorised, and who is not authorised, to make independent inquiries into Covid-19. You cannot look at the virus, measure it or develop a test kit for it without the permission of the CDC. This, obviously, restricts the amount of research that can be conducted on SARS-CoV-19-2.

Few people realise that the CDC is not an independent government agency, rather it is largely and privately owned by a number of shadowy organisations (#9.2).

The film Plandemic 2 Indoctrination, which has set the world record with almost two million unique viewers tuning into the live streamed world premiere, was being supported in September 2020 by more than 27,000 medical doctors, a number that is continuously increasing (#10).

Covid-19’s Propaganda Campaign was Evident from the Beginning

When the Covid-19 crisis in Wuhan exploded in the media early in 2020, I instinctively recognised a propaganda campaign. For one thing, as it was reported it made no sense that very sick people with Covid-19 were being forcibly pulled out of homes, and dragged away from sobbing loved ones by medics in hazmat suits, locked in the backs of vans, driven to hospital, then forced along corridors struggling with great resistance. These people did not look desperately ill, they looked terrified and confused. Also, I have never known the media to deliberately terrorise people worldwide with a continuous barrage of fear-mongering headlines and images on such a scale as this (not even during 9/11).

Then things just got weirder... Nothing about Covid-19 made sense.

I have worked in the media for more than 30 years and understand how the modern mainstream media operates – *it is inherently untrustworthy and nothing should be taken at face value*. This is because the views presented in each publication must be in line with the publisher’s expectations, which places huge restrictions on editors and journalists.

When it comes to independent journalists, they have more freedom but they still have to find someone to publish their work. And when it comes to reporting on lies, cover-ups and conspiracies in high places, a journalist can be targeted with a smear campaign to discredit them. They can even be threatened, as Vanessa Beeley recently experienced from the BBC (#11.1). Others, such as former

Merk Pharmaceutical rep turned vaccine safety advocate Brandy Vaughan, have died under suspicious circumstances for speaking up for the truth ([#11.2](#)). In fact, **21 journalists were murdered globally in relation to their work in 2020** ([#11.3](#)). Some cross over into the alternative media where their voices are not silenced, but they have a much smaller audience.

So when I was confronted with the Covid-19 news hysteria, which made little sense, I decided to investigate. I understand that most people have not had the luxury of spending months researching this full time. Nevertheless, truth does matters, especially for Christians, because truth is an attribute of God. This is particularly important when we consider where these developments are heading and how much they align with Jesus' answer to His disciples' question, "When will the end be? And what will be the sign of Your coming, and the end of the world?" (Matt 24:3).

A Worldwide Pandemic Predicted by Dr Fauci in 2017

In Plandemic 2 Indoctrination, national intelligence analyst, CEO, and inventor, Professor David Martin, who investigates patents and has been uncovering corporate conspiracies for more than 20 years, explains the history of the Covid-19 virus. In 2003, the US was engaged in chimeric research (e.g. combining human genes with genes from other species). This was despite there being a moratorium against it and when the research got too edgy in 2014, it was sent off shore by the White House's leading infectious disease expert, Dr Anthony Fauci, to the Wuhan Institute of Virology in China.

The National Institute of Health transferred \$3.7 million dollars of US taxpayers' money to China to continue the research. **That is how the virus ended up in Wuhan.** Also refer to Brian Rose interview with Dr David Martin at Londonreal.tv, and a presentation by Dr Rashid Buttar ([#12.1](#), [#12.2](#)).

Then, in a 2017 speech at Georgetown University in Washington, Dr Fauci predicted a pandemic during Donald Trump's presidency, saying, "... **there is no question that there will be a challenge in the coming administration arena of infectious diseases... there will be a surprise outbreak ...**"([#13](#)). Prior to that, in 2015, Bill Gates spoke at a TED Talk fearmongering that CO₂ is warming the planet and leading to an ecosystem collapse. Much of this CO₂, he said, comes from all the people and the services they require. Consequently, changes are needed to bring that down. His solution? **New vaccines can help to reduce the world's population by 10-15% – around one billion people** ([#14](#)).

Important information on Bill Gates: After he reinvented himself as a philanthropist in 1994, by entering the vaccine market, his wealth doubled from US \$54 billion to \$103 billion dollars. He speaks of how the vaccine industry gave him a "20 to 1 return". As critics point out, with nine million people dying each year from lack of food and clean water, wouldn't it have been more benevolent for Gates to have provided these people with the basic necessities of life rather than embark on costly medication programs for rare diseases? But there is no financial return on an investment made from that kind of charity ([Meet Bill Gates #15](#)).

It should also be noted that Bill Gates, Jeff Bezos, Elon Musk, Mark Zuckerberg and 18 other oligarchs celebrated a US\$2.2 trillion dollar increase in wealth (up from US\$8 trillion dollars) during the first three months of the Covid-19 crisis. They did this by buying into the stock market during lockdowns before world governments launched their stimulus packages ([#16](#)).

This was against the backdrop of a world economy that plunged \$10 trillion into debt in the first six months of the Covid-19 pandemic, according to the World Economic Forum (WEF) ([#17](#)). Furthermore, the World Bank and United Nations report that these very same lockdowns will lead to food supply disruptions and a doubling of global starvation in 2021. Yet there are still people who dismiss those who uncover crony capitalism, corporate conspiracies, insider trading and conflicts of

interests as being absurd “conspiracy theorists”. Others see these people who join the dots as “coincidence realists”.

Tens of Thousands of Doctors/Health Care Professionals Exposing Covid-19 Disinformation

As with **Germany, Spain** and **The Netherlands**, hundreds of medical doctors in **Belgium** are also fighting to expose the country’s unscientific response to the SARS-CoV-2 outbreak and the need for open discussion among all parties. Refer to the ‘Open Letter from Medical Doctors and Health Professionals to All Belgium Authorities and All Belgium Media’, September 2020 (#18). Be sure to click on the ‘Signed by’ link in the second paragraph as it will take you to the updated number of signatories, which now stands at **689** medical doctors; **2274** medically trained health professionals; and **17,454** citizens. The petition was stopped in early December (#19.1 video has older statistics.) In **The Netherlands**, **2500** healthcare professionals (which includes **800** doctors) have signed a similar open letter petition, before it also stopped (#19.2).

In the **US, America’s Frontline Doctors** are also trying to educate the public about the massive Covid-19 disinformation campaign. In July, 2020, they held a press conference outside Capitol Hill on how media, special interests and politics are preventing doctors from treating patients with Covid-19. In only a few days their video received more than **20 million** views, then it was censored by Facebook, Vimeo, Twitter and YouTube, and Dr Simone Golding, MD, JD, who headed the campaign, was dismissed from her job (#20). These doctors held another press conference on October 17, 2020 (#21). Their website is a mine of information, but their videos continue to get taken down.

The 600 **Spanish ‘Doctors for Truth’** made a similar statement during a press conference: ‘Covid-19 is a false pandemic created for political purposes. This is a world dictatorship with a sanitary excuse. We urge doctors, the media and political authorities to stop this criminal operation by spreading the truth’,” (#22). That was back in July 2020 and their numbers are also growing. As to be expected, the Spanish Doctors for Truth Facebook page has been taken down and their YouTube account has been terminated. Fortunately, somebody has reposted it on independent video hosting service Bitchute (#23). In a news report that has also been uploaded onto Bitchute, Spanish Dr Luis de Benito publicly denounces the government’s Covid-19 narrative. His refusal to go along with the prescribed story upsets his interviewers who try to discredit him on air (#24.1).

On top of all this, by January 2021, **53,497** medical practitioners and medical and public health scientists (and **727,270** concerned citizens) have signed **The Great Barrington Declaration**, which has been authored by three distinguished infectious disease experts – Professors Martin Kulldorff, Sunetra Gupta and Jay Bhattacharya. (*And, again, this number is increasing daily.*)

The Declaration lays out the dangers of the current Covid-19 policies and states that herd immunity, which will lower the risk of infection in a population, is not a strategy it is a biological fact, and all the governmental restrictions are hindering this natural process. Ultimately, the goal must be to protect the vulnerable, stay home if you are sick and let everyone else get on with their lives, and Covid-19 will eventually pass as every other disease has. Nevertheless, governments refuse to listen (#24.2; #24.2.1).

Interestingly, a November 2020 study, compiled by 19 scientists and published in the scientific journal Nature Communications, found that out of 10 million people in Wuhan, China, there was no asymptomatic transmission of Covid-19. This, of course, debunks the need for lockdowns, which are built on the premise of the virus being spread by asymptomatic people. Argued Jeffrey Tucker from the American Institute for Economic Research, “**With solid evidence that asymptomatic spread is nonsense, we have to ask: Who is making decisions and why?**” (#24.3)

Britain's Neil Ferguson's Mathematical Model Compared to Witchcraft

Early on in the Covid-19 crisis, governments throughout the world were influenced by Professor Neil Ferguson's scientific modelling (funded by Bill Gates), which claimed multiple millions of people would die worldwide from the disease. **This information is now known to be completely fraudulent.** Ferguson's doomsday projection (which had not been peer reviewed) claimed there would be 2.2 million deaths in the US alone. In reality, however, the death count as of January 2021 stands at 414,000 in the US. The utter failure of his modelling was discovered after the Imperial College of London was forced to make Ferguson's secret code available to independent researchers, but not until a delay of six weeks (during which time he tinkered with his model) after he had been called out on it.

According to software engineer investigators, Ferguson's coding was found to be so unscientific, it was likened to one step above "witchcraft". After Ferguson's model was completely discredited, he resigned from his job and disappeared. Nevertheless world governments are still operating from his projections one year on (#25.1).

In Australia, the "horrendous Covid-19 scenario", predicted by Australia's Former Chief Medical Officer Brendan Murphy, claimed there would be a daily demand for an extra 35,000 plus intensive care beds to be maintained. With only 909 deaths as of January 2021 (0.0035% of Australians, mostly over 80 years old), this mathematical model has been termed "research misconduct" (#25.2, #26.1). Yet, the restrictions continue, because major corporations have made business deals with world governments over the years (#26.2).

For example, in 2013 the Rockefeller Foundation announced Melbourne had been selected for funding as one of its 33 Resilient Cities, commencing in 2016: "...cities who have demonstrated a dedicated commitment to building their own capacities to *prepare for, withstand, and bounce back rapidly from shocks and stresses*" (emphases added, #26.3). Is it *really* a coincidence that Melbourne has suffered some of the most Draconian lockdown measures in the world, and that Dr Anthony Fauci has "praised Victoria's response to the coronavirus pandemic"? (#26.4)

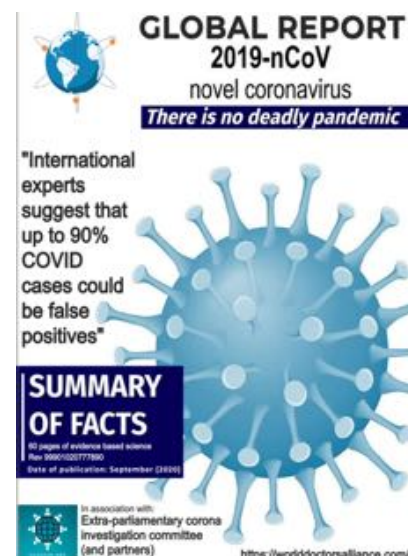

CHAPTER 2: THE MEDIA AND WHO IS CHECKING THE FACT CHECKERS?

Google, Facebook, Wikipedia and Fact Checkers

Not many people know that after decades of mergers and acquisitions more than 90% of everything we read, listen to and watch is now owned and controlled by a half dozen corporate empires:

Comcast; The Walt Disney Company; TimeWarner; 21st Century Fox; CBS and Viacom. Also, few realise that the accepted narrative, presented by news and current affair and talk show hosts, is often repeated over and over again across all networks (following the script they have been given) word for word in most cases, with no one checking the facts. This is because many news stories are not generated on the back of publicly accessible data but are literal corporate press releases.

Internet search engines also play a big part in subverting the truth (refer to 'Plandemic 2 Indoctrination'). For example, **Google** is the most influential search engine in the world and most people consider it is an authoritative and unbiased pathway to truth. However, as James Corbett explains (in 'Who is Checking the Fact Checkers?') Google was *never a search engine* (based on a Dewey-type of classification system). Rather, it is an *opinion curator engine*. In other words, Google selects its own recommended content so that a person only sees what it wants them to see. In this way Google controls the narrative *without people realising it*. Also, most people are unaware that many fact checkers are fake news sources, e.g. Snopes, Politifact, NewsGuard and FactCheck (#27.1).

Thanks to software engineer whistleblowers, we find that **Google has a black-list algorithm of search terms it does not want people to view**. It also has algorithms that direct people to fake news items about people and organisations that pose a threat to the interests or revenue of its parent company Alphabet and Alphabet's subsidiaries, which include Big Pharma and Big Tech corporations (#27.2). Of note is the fact that "Google is poised to make a profit from the Oxford-AstraZeneca vaccine at a time when its video platform YouTube has moved to ban COVID-19 vaccine-related content that shines a negative light on COVID-19 vaccines, including the Oxford-AstraZeneca candidate" (#27.3; #28.1). Google also "buries" news stories of critical importance, making it virtually impossible to find them using internet browsers.

Thus googlers are kept ignorant of the fact their internet searches are being covertly directed along a specific path with a specific objective mandated by Google.

With regard to Facebook, The Epoch Times reports: "While **Facebook** portrays its army of fact-checkers as independent, the money behind at least one carries a distinct taint. One of Facebook's main fact-checkers is Lead Stories, a company that has received funds via Facebook, Google, and TikTok owner ByteDance, which has ties with the Chinese regime" (#28.1.1).

Wikipedia is another unreliable source. Considered to be an open and transparent online encyclopaedia, closer inspection shows this is not the case. Researchers have found, for example, that Wiki editors have included CIA and FBI operatives and British intelligence officers who have been editing articles on controversial topics while destroying the reputations of independent journalists and politicians who hold to counter narratives. Furthermore, these editors can block disagreeing users. Not surprisingly, Wikipedia's founder, Jimmy Wales, has amassed a \$160 million fortune donated by major US corporations and influential foundations (#28.2).

Respected news sources are also guilty of skewing facts, twisting the truth, and planting or supporting fake news. For example, **Australian Associated Press's 'Fact Check'** correctly exposed a false argument circulating on social media that the inventor of the PCR test (Dr Kary Mullis) claimed his test would not work for Covid-19. After all, Dr Mullis died two months before Covid-19 appeared.

However, the writer of the article did not then correct this error with the *facts* – that Dr Mullis made it clear his PCR invention *cannot be used to diagnose any virus, because that is not what it was designed to do* (#28.3). Thus AAP's 'fact checking' is deliberately misleading the reader.

Big Media, Big Tech and Big Pharma Connections

Most people do not realise their perception of reality is being shaped by these sources (Google, Wikipedia, "fact checkers", fake news and the mainstream media, etc). Furthermore, few people know how compromised the corporate media is with conflicts of interest, even medical journals have come up against this problem. This was recently evidenced at *The Lancet* and *The New England Journal of Medicine*, which had to retract a Covid-19 study against the use of hydroxychloroquine (HCQ) as it had bypassed the normal peer-checking procedures. The gatekeepers of science are academic journals, which are meant to have peer-reviewed robust processes to validate scientific conclusions. America's Frontline Doctor, Dr James Todaro, exposed what has been going on with these processes. **"What we have seen is unprecedented corruption within those academic journals.** In the past six months two of the top medical journals in the world, *The Lancet* and *The New England Journal of Medicine*, produced openly fraudulent studies that have benefited Big Pharma" (#28.4).

The World Health Organisation did eventually reverse its decision against HCQ as a treatment for Covid-19, but this has not been reported in the mainstream media. As such, the damage has been done and HCQ (a 60-year-old generic drug that does not make any profit for Big Pharma) has been successfully and wrongfully demonised (#29.1). The editors of these journals have complained for years about the influence and pressure being levered on them by pharmaceutical companies as to what is being published in these journals. This is the result of a direct conflict of interest, because much of the revenue for these journals comes from pharmaceutical advertising and sponsorships.

All this I learnt through independent and alternative media platforms, which are not funded or controlled by Big Media, which itself is 90% owned by Big Pharma. This research led me to many insightful and discerning professionals, who, also challenged by Covid-19 misreporting, set out to find the facts outside the constraints of the mainstream narrative. One reliable source led to another (some of whom are Christians) and soon I was able to find a network of trustworthy authorities from around the world, all capable of deconstructing and making sense of the same phenomena and coming to the same conclusions. (I had no difficulty weeding out a small number of extremists and crackpots on these alternative media platforms.)

Thousands of Professionals are Challenging Mainstream Narrative

What I have discovered this past year is that there are tens of thousands of professionals who have also been baffled and challenged by the dissonant reporting of Covid-19, in which the hype, panic and confusion around the virus is bigger than the disease itself: e.g. Nobel Prize winners, Supreme Court judges, doctors, nurses, respiratory therapists, pathologists, internationally renowned influenza specialists, microbiologists, virologists and epidemiologists, infectious disease experts, chief head scientists, medical researchers, death certificate registrars, funeral directors, medical journalists, editors, attorneys, lawyers, senators, bankers, politicians, authors, military officers, environmentalists, activists, investigative journalists, investigative filmmakers, broadcasters and a host of others, including ordinary citizens (#29.2).

As Dr Andrew Kaufman explains, **"This generated crisis has been highly coordinated by a group of people who are directing the governments, which is compatible with the globalist agenda of moving towards a one world government. It is all laid out in the United Nations document Agenda 21, which has been renamed Agenda 2030. It calls for a reduced population and tighter control over the people"** (#30).

Other people point out the raft of unprecedented laws being clandestinely introduced by governments around the world. An example of such laws has been voiced by Dr Michael Ryan, Executive Director of the WHO Health Emergency Program, who says health workers need to be able to enter people's homes (forcibly) and remove people (even children) in order to isolate them if sickness is suspected (#31). In some countries (e.g. China) people have been forcibly quarantined and vaccinated, and people who refuse to wear masks have been shot (Indonesia).

There are also frontline nurses who have spoken about gross medical malpractice at the epicentre of the Covid-19 outbreak in NYC, where the treatments were killing more patients than the virus (#32.1). One nurse was Erin Marie Olszewski, who worked at the Elmhurst Public Hospital in New York. Erin was more than qualified to handle a pandemic situation. She had served in combat hospitals in Iraq and received the Army Commendation Medal for meritorious service and had been wounded in combat. What she witnessed in Elmhurst, however, shocked her to the core. "All people entering the hospital were admitted straight into Covid-19 wards even if they were not sick. **This is because the hospital was paid \$13,000 dollars for diagnosing someone with Covid-19 and \$39,000 if that person was put onto a ventilator.** The misapplication of ventilators killed every single 'Covid-19' patient. **It was an assembly line – from ER into a body bag"** (#32.2, #32.3).

Others speak of how the coronavirus restrictions and lockdowns are creating a financial nightmare that is unleashing a devastating economic chain of events leading to the collapse of the world economy. There is talk of skyrocketing unemployment and mounting national debt, the sharp rise in suicides and domestic violence, escalating mental health problems, the rise in deaths from heart disease and cancer patients who have had their treatments delayed, and the many charities and humanitarian projects that will suffer financially because of it.

According to Ellie Grey, organiser of the August 2020 London rally, 60% of people in the UK were living on government hand-outs (#33.1). **This rally and others have received no media coverage, even though tens of thousands of people showed up to protest government lockdowns and restrictions** (#33.2). Other countries that have had anti-lockdown protests (some peaceful and others violent) are Germany (millions of protesters), Greece, the Czech Republic, France, Spain, Italy, Brazil, Slovenia, Poland, Canada, the US, Lebanon, Hong Kong, Serbia, Ukraine, Russia, Nigeria, India and Israel, again with no mention in the world's mainstream media (#33.3, #33.4; #33.5; #33.6).

There are also doctors who are confused about governmental instructions to falsify death certificates, with those questioning it receiving threats they will lose their licence (#34 and #35). In Indonesia, relatives of people who have died of anything are given welfare cheques from the government if they agree to "Covid-19" being put on the death certificates. As an Indonesian friend explained: these people are more than happy to comply, because they *never* get money from the government for *anything*. Also, a friend from Latvia has told me if a person dies there, the funeral home offers a free cremation if they allow Covid-19 to be put down as the cause of death.

Covid-19 Death Numbers being Manipulated and Falsified

Doctors speak of how people who have died of cancer, Parkinson's disease, hip fractures, gunshot wounds, suicide and even motor vehicle accidents are being added to Covid-19 statistics. Dr Stoian Alexov, President of the Bulgarian Pathology Association, has said the WHO has deliberately created chaos by prohibiting almost all autopsies on people deemed to have died from Covid-19. Of the autopsies that had been carried out, none of them showed that the virus was deadly. **He has called the WHO a "criminal medical organization" for creating worldwide fear and chaos without providing objectively verifiable proof of a pandemic** (#36). This prohibition on autopsies, says Dr Alexov, means it has not been possible to disprove or confirm the theory that many of the people

said to have died of Covid-19 in Italy had previously received the H1N1 flu vaccine, which suppresses adult's immune systems and could have contributed significantly to their deaths (#37).

US death recording clerk Joy Fritz explains how governments have told doctors (who adhere to the international standard coding for death certificates) to switch *immediate cause of death* with *underlying (primary) cause of death* in all patients who have tested positive for Covid-19. (Remember that 90% of PCR tests show false positives.) In this way, Covid-19 is now coded as the primary cause of death even if the deceased had no symptoms of the virus but simply died WITH the virus according to hugely inconclusive PCR testing. This is another way to falsely inflate the Covid-19 death numbers. **This manipulation of death certificates, she explains, is a serious matter, because it affects statistics and research funding for future generations (#38.1).**

Here is an example. On January 26, 2021, the National Health Service on the Isle of Wight (in the UK) responded to an inquiry regarding the exact number of deaths on the island from **Covid-19 only**. The inquirer explained they did not want the number of deaths where people had died, say, of a heart attack, but where Covid was put on the death certificate. The NHS replied that they had medically certified all deaths in line with the guidance issued by the NHS England Coronavirus Act March 2020. That is, if a C19 swab was positive within 28 days of death, regardless of other medical conditions or an underlying cause of death, that person was registered as a Covid-19 death! (#38.2)

Also, NYC funeral directors have reported that Covid-19 was written on death certificates because it meant extra federal funding for public hospitals. And people have received letters saying their relatives died of Covid-19, even though they had died months before the "pandemic" (#39.1). What's more, a high percentage of hospitalised patients officially counted as positive cases were, in fact, being treated for different illnesses not related to COVID-19. They had only tested positive for the disease at the hospital without displaying any symptoms (39.1.1). And consider, since the "pandemic" began we are not hearing a spate of ambulance sirens, funeral directors are reporting their workflow is normal, cemeteries are not packed with mourners, and many nurses are out of work (#39.1.2).

Fake News on Covid-19 Deaths Exposed

Investigative journalist James Corbett shines light on the facts behind the news reports of New York City's mounting Covid-19 death count early on in the "crisis". Footage showing what appears to be bodies being loaded into refrigerated trucks parked outside hospitals then shipped off to Hart Island to be buried in mass graves, because cemeteries were overflowing, was fake. In truth, Hart Island has been the mass grave burial site for 68,955 unidentified or unclaimed adults and infants since 1980. Today, 100 bodies are buried there each week. It has nothing to do with Covid-19 deaths. As Corbett points out, although people did die of the virus during this time, the huge numbers of deaths being reported was not reflected in the actual New York City death statistics in this period (#39.2).

For more on fake news, empty hospitals and Neil Ferguson's unscientific Covid-19 mathematical model, refer #40. There are also investigative journalists in different countries who have entered hospitals (in Germany, the US, England and Brazil) said to be full of Covid-19 patients only to find them virtually empty and staffed by doctors annoyed by the farce (#41.1; #41.2). And whistle-blower medical staff have revealed how fake news was generated, having secretly filmed staged "stressed" hospital workers and fake patients. These whistleblowers have uploaded their videos onto social media and told independent media sources that dummies were used to depict dead patients for the news cameras, and that rooms packed with "critical" new ventilators were never used (#42; #43).

One British journalist compared the number of people dying in the UK over the same period of time in 2018 and in 2020 and found there was only an increase of 169 deaths. This is because as the Covid-19 death count rises other causes of death mysteriously disappear (#44). In the US, the CDC

has produced a similar report, showing fewer deaths in 2020 than in 2019. **US talk show host Steve Deace uses CDC data to prove there has been no rise in death numbers during the US Covid-19 pandemic (#45)**. High-ranking Russian intelligence military officer (with a PhD in military science), Vladimir Kvachkov, has described the pandemic as **“a global strategic special operation in political and social engineering” (#46.1)**.

Prime Example of How Big Media Silences Covid Medical Debate

In February, 2021, the BBC aired a Panorama documentary titled ‘Vaccines, the Disinformation War’. This documentary attacked another documentary – ‘Ask the Experts’, which was produced by Oracle Films in conjunction with CoviLeaks. Ask the Experts had brought together scientific and medical experts from around the world to discuss the safety and efficacy of the Covid-19 vaccines. The 33 medical professionals in Ask the Experts were speaking for themselves and not as a collective. They was no financial incentive and great personal risk to their reputation and livelihood. However, the BBC tore them to shreds for “spreading dangerous misinformation and targeting vulnerable people”.

In response to Panorama’s inflammatory documentary, Oracle Films released a sequel – Ask the Experts 2. As the narrator explains (paraphrased): “We do not intend to question the scientific prowess of the critics featured on the BBC documentary, however, we would be remiss not to point out the multiple, flagrant conflicts of interests of these people”. The program then goes on to reveal the hundreds of millions of dollars donated to various institutions behind the Panorama program and connected with the BBC. For example, epidemiologist Prof Liam Smeeth, from the London School of Hygiene and Tropical Medicine (LSHTM), was a prominently featured critic in the Panorama documentary. But a quick browse of the awards section of the Bill & Melinda Gates Foundation shows that the LSHTM has received 122 grants over 20 years to a total of more than \$250 million in donations. The BBC’s Media Action has also received donations from the Bill & Melinda Gates’ Foundation – \$50 million in the same time frame. Check out the video below.

Oracle Films followed up ‘Ask the Experts 2’ with ‘The Pushback’, in which Dr Mike Yeadon, former Vice President and Chief Scientist for Pfizer, says: “The idea that everyone is a biohazard, dangerous until proven healthy, was invented in 2020. There is no history of people being ill, having no symptoms and being a threat to others... You don’t need masks; they don’t work. Forget lockdowns; they never slow transmission. You don’t need to be vaccinated by inadequately tested and somewhat dangerous gene-based, spike protein inducing proteins. And you don’t need to do what you are told by corrupt scientists who are advising our governments.”

CHAPTER 3: INFORMATION ON THE DIFFERENT TYPES OF COVID-19 VACCINES

If anyone is not informed about the different technologies behind the Covid-19 vaccines, it is time to get up to speed quickly, as right now a number of vaccines are being rolled out around the world to hundreds of millions of people. **For those people who may have already received a vaccine, this is equally important.** This is because Big Pharma and governments are telling us we will need to be revaccinated every year, for the rest of our lives, because Covid-19 is never going away! As such, each person NEEDS to know what is being injected into their bodies and whether they want to begin or continue with these vaccination programs. The dangers in these vaccines, warn many doctors and scientists, are too great to be justified against a virus that kills less than 1% of the people it infects.

But first, some encouragement for people who may have already received the Covid-19 vaccine.

Each one of us has to make decisions with regard to health issues in our life, often without any knowledge of what will be of most benefit. As someone who was diagnosed with cancer in 2019, I understand this dilemma all too well. However, there is genuine peace in knowing that whether our choice was right or wrong, ultimately our life is in God's hands, and he loves us and he will work with us according to his greater purpose. He may heal us when we are sick, or he may extend our life, or he may protect us when we are in danger.

However, if he chooses not to heal or protect us, we can rest assured in the knowledge that he promises he will always be with us, strengthening us during times of trial, and he will never take us beyond what we can bear. Also, our trials are not without purpose; they are to help us grow in faith and the knowledge of our Heavenly Father. But let patience have its perfect work, that you may be perfect and complete, lacking nothing" (Jas 1:2-4).

Whatever our trial, we need to praise God and trust him in every circumstance in our lives. This is the pathway to true peace. Furthermore, those who have made Christ Lord of their lives know the future awaiting them in the next life is more magnificent and exciting than anything we could imagine. "Be anxious for nothing, but in everything by prayer and supplication, with thanksgiving, let your requests be made known to God; and the peace of God, which surpasses all understanding, will guard your hearts and minds through Christ Jesus." (Phil 4:6-7)

"And we know that all things work together for good to those who love God, to those who are the called according to His purpose." (Rom 8:28). "For I know the thoughts that I think toward you, says the LORD, thoughts of peace and not of evil, to give you a future and a hope." (Jer 29:11)

"In God I have put my trust; I will not be afraid. What can man do to me?" (Ps 56:11)

Here I discuss the following subjects: The History of Vaccines; Five Different Vaccine Types; The Matter of Intellectual Property Rights; The Dangers Associated with These Vaccines; The Crime of Uninformed Consent; Conflicts of Interests Between Vaccine Manufacturers and Governments; How Drug Trials Work and How They Have Been Rigged; What Efficacy and Recovery Means; Big Tech Censoring Vaccine Adverse Events and The Vaccine Injury Act of 1986.

This section is about 14 pages long (and constitutes months of research). **Deciding whether or not to get vaccinated against Covid-19 or whether to continue with the vaccine program really is one of the biggest decisions a person will make in their life.** However, if the reader is not that interested in

The History of Vaccines and How They Work

It is important to understand when vaccines were first invented and how they worked. In his excellent documentary **The Future of Vaccines** (#46.2), James Corbett of The Corbett Report explains that the concept of inoculation had been around for centuries. One of the earliest vaccines was in China several centuries ago, where dried-out scabs of lightly infected smallpox sufferers were powdered and then blown up the nostrils of healthy people. The procedure aimed to infect the patient with a mild strain of smallpox, thus conferring immunity on them. This successful practice was brought over to Europe via Turkey and was eventually adopted around the world.

“Vaccination” developed in the late 18th century when Edward Jenner discovered that those who had been exposed to cowpox—a less virulent relative of smallpox—were themselves immune from smallpox. So he “vaccinated” a boy with a cowpox vesicle from a milkmaid and then inoculated him with smallpox two months later. The boy did not develop smallpox and the procedure was hailed as a breakthrough of medical science. **The word “vaccine” came to refer to the general process of introducing immunogens or attenuated infectious agents into the body in order to stimulate the immune system to fight infections.** (“Attenuated” simply means weakened.)

An abstract in PubMed in the NIH Library states that vaccine technology is constantly changing and vaccines contain a number of toxic substances, such as mercury, aluminium derivatives, arsenic, barium, cadmium, chromium, lead, thallium and zinc (#46.2.1), formaldehyde, animal viruses and other poisons. These toxins are added to the vaccine (used as adjuncts), in order to aggravate the immune system to respond to the invading antigen (disease).

What Are Immortal Cell Lines – MRC-5, PERC6, WI-38, HEK-293, WALVAX2, RA273?

Many modern vaccines contain MRC-5, PERC6, WI-38, HEK-293, WALVAX2, RA273 and human diploid cell line. These cell lines originated from hundreds of aborted babies who were dissected while still alive, because you cannot derive a living cell culture from tissue that is already dead (#46.2.2). Some of these abortions were ‘abdominal hysterectomies’, in which the babies were removed from the mother with the entire uterus intact and then stored alive in a fridge until they could be dismembered (#46.2.3).

The tumour suppressant genes in these baby cells have been genetically altered so they continue dividing indefinitely. That is why they are also called “immortal cell lines”. But tumour suppressant genes are important for signalling the cell to stop dividing when the likelihood of DNA damage is high, and any cell that divides continuously (particularly if it is damaged) is an abnormal cell – this is called cancer. Many medical professionals today believe these immortal cell lines are, in part, responsible for the huge rise of cancer diseases in our modern world (#46.3).

James Corbett reports, in his must-see documentary ‘The Future of Vaccines’, how vaccine **technology today bears little or no similarity to the original scientific method centuries or even decades ago. Very few people, however, realise this, even doctors.**

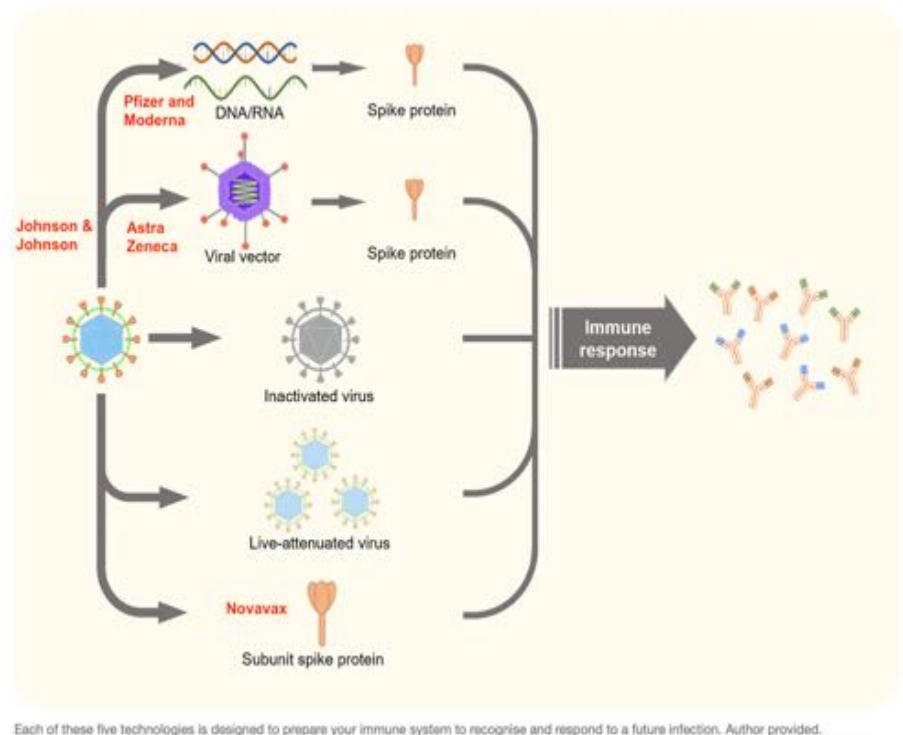
Robert F Kennedy Jr has been labelled an “anti-vaxxer” by the media because he draws attention to the dangerous components used in the vaccine industry. Kennedy tweeted: **“I’m not anti-vaccine. I’m against dangerous, shoddily tested, zero liability vaccines with toxic ingredients. If someone came up with a thoroughly tested vaccine that was completely safe and efficacious, one that performed as promised, one that made people healthier rather than sicker, I’d be for it...”**

RFK also states: “Bill Gates is the world’s largest vaccine producer and the single largest donor to WHO and the CDC Foundation. Those agencies are now marketing arms for his vaccine empire... Google is a vaccine company. It has a \$760 million partnership with Glaxo-the world’s largest vaccine maker and similar deals with Sanofi and Merck to mine your medical information. Google’s mother company, Alphabet, has 4 vaccine developers working on flu, and other, vaccines” (#46.4).

That aside, the Covid-19 vaccinations are in a class of their own. This is because not only are manufacturers exploring new scientific methods, but **no coronavirus vaccine has ever been effective before** – in fact, they have all proven dangerous.

Overview of Five Vaccine Technologies

According to The Washington Post, **190 Covid-19 vaccines** are being developed around the world. These are grouped into five main types – **DNA/RNA** (gene-based); **VIRAL VECTOR** (a virus is delivered via an artificial vehicle); **INACTIVATED VIRUS** (dead virus); **LIVE-ATTENUATED VIRUS** (weakened virus) **SUBUNIT SPIKE PROTEIN** (#47.1). (I have placed the names of four Covid-19 vaccines next to their delivery system type in the illustration opposite.)



RNA and DNA Gene-Based Vaccine Technology

Today’s drug manufacturers tell us that the problem with the old-school vaccines, which contain a weakened virus in various toxic chemicals, is that they take a long time to produce. Not so, with experimental 21st century DNA and RNA vaccine technology, which takes a fraction of the time. Messenger RNA vaccines do not need a virus, just a small gene sequence that is then coded and sent into the body. **Messenger RNA (mRNA) technology is a subtype of RNA vaccines** (#47.1.1).

These experimental gene therapy vaccines are a new and uncertain era of vaccine development. Writes Dr John Whyte, the chief medical officer of the health care website WebMD, in late November 2020: “**The key will be how does this new technology compare in terms of safety and efficacy compared to older technologies**”. No wonder anti-Covid vax protesters are holding placards stating that governments around the world are using humans as guinea pigs in this trial!

Dr David Martin explains that the medical/legal definition of “vaccine” is that it must provide protection against contracting the disease if exposed to the virus and that it stops the transmission of the disease. It also has to be a preparation of inactivated (killed) or live-attenuated (weakened) living microorganisms (#47.2.1; #47.2.2).

This is really important, because the DNA/RNA (gene-based) Covid-19 “vaccines” do not fulfill either of these requirements. Both Pfizer/BioNTech and Moderna admit this about their mRNA vaccine technology. That is because they do not use inactivated or live viruses. Rather, they use gene therapy technology similar to that for genetically modifying animals and crops (explanation next page). Also, as England’s deputy medical officer reports, “even after you have had both doses of the vaccine you may still give COVID-19 to someone else and the chains of transmission will then continue” (#47.3). Thus Pfizer and Moderna are not, by definition, vaccines. All of which should make people wonder... what is the purpose of these so-called vaccines if they do not protect an individual from getting the virus or spreading it?

Dr Sherri Tenpenny has spent more than 20 years and 40,000 hours studying the evolution of vaccine technology and writing books about it. She explains that RNA vaccines have existed for years (e.g. for measles and polio), but we have never used **messenger mRNA (mRNA)** in any human vaccine technology before. **The difference between RNA technology and mRNA technology is that the RNA vaccine carries the virus wholly intact into the body. When the body detects it, it generates antibodies to attack the outer-coating proteins of that virus.** This is meant to teach the body to identify, by memory, the virus as a pathogen the next time it enters the body. However, this is not what happens with the new and experimental **mRNA technology**. In this case, the **mRNA vaccine carries a virus-replicating code into the cells, instructing them to start creating the virus spike proteins inside the cells themselves.** Science calls this the Trojan Horse Mechanism. **Bill Gates has said of this technology that human beings can become their own vaccine machines.**

Dr Tenpenny explains that macrophage cells are an essential component of our immune system. There are two types of macrophages – M1 and M2. M1 is highly inflammatory and very aggressive. It engulfs, attacks and kills pathogens. M2, on the other hand, is anti-inflammatory. It turns up at the infection site after the attack, settles things down, cleans up the debris and heals it. These two work in concert. But when a person has the antibody to the spike protein, which is the intent of these vaccines, that antibody attaches to the M2 macrophage, inactivates and kills it. Thus it cannot do its job. This leads to a cytokine storm – the result of an immune system gone wild. This can lead to organ failure and death (#47.4).

Pharmacist Sandy Lunoe from Norway tells us that both **Pfizer and Moderna** use lipo-nanoparticles that contain **Polyethylene Glycol (PEG)**. Lipids exist naturally throughout the body and may be digested. But when introduced via a vaccine, this can cause the immune system to see all lipid substances, including the lipid nanoparticles in the vaccines, as invaders. The body’s response is to create antibodies against them. The result is autoimmune disorders. **PEG has never been used in an approved vaccine before and may cause severe allergic reactions and anaphylaxis.** The complete list of vaccine ingredients is not necessarily revealed (#49.8.2).

Pfizer and Moderna are Not Vaccines – They are Medical Devices

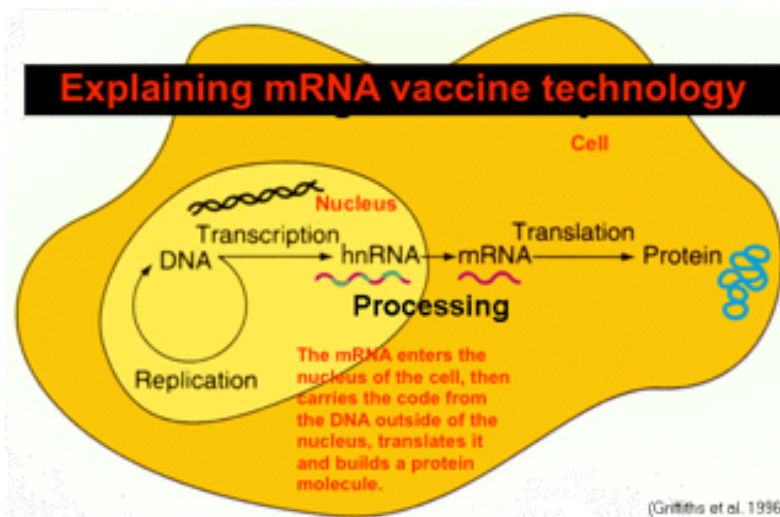
Pfizer and Moderna are gene therapies, says medical inventor Dr David Martin, which meet the CDC’s requirement for a **medical device** and *not a vaccine*. He explains that this gene therapy involves injecting synthetically coded messenger RNA (mRNA), packaged in a fat envelope (PEG), which is delivered into a cell. This medical device is programmed to stimulate the human cell into manufacturing a synthetic coronavirus spike protein within the cell.

The reasoning behind this is that when a person is then exposed to the virus, their body is meant to immediately recognise the invading coronavirus spike protein and attack it. Dr Martin theorises that if Pfizer, Moderna and Dr Fauci actually called it gene therapy people would not want to take it. **And for good reason, because experimental gene therapy is a bad idea. Period!** (#47.2)

Thousands of doctors worldwide are making their voices heard through numerous petitions to governments: **gene therapy should never be relentlessly and recklessly distributed to a population.**

There are number of reasons these pharmaceutical companies are falsely marketing their drug technology as a vaccine. 1) They can get their product distributed faster under the Emergency Use Authorisation (EUA) rules for vaccines, meaning they do not have to complete the normal timeframe governing drug trials over many years. (EUA only calls for limited preliminary trials with relatively few people in cases of national emergencies.)

2) By claiming mRNA gene-based technology is a vaccine, these companies can claim a shield of protection against liability for death and injury, as they are covered under the Vaccine Injury Act of 1986 that makes them exempt from prosecution if things go wrong (#47.5). 3) Worst of all, these companies now have legal access, via governments, to billions of people throughout the world to test their experimental drugs.



Dr Andrew Kaufman explains, the nucleus of a cell is [miraculously] created [by God] to prevent any such invasion. Dr Kaufman described messenger RNA as being equipped with a sort of key that allows it to unlock the gate into a cell's nucleus. **What man is doing with this technology is basically playing God.** This mRNA process, says Dr Kaufman, of injecting certain components that are designed to pierce the nucleus in a person's cells and to synthetically alter their RNA, has never been done before. Dr Anthony Fauci agrees, no mRNA vaccines have ever been approved (47.5.1).

As for **DNA gene-based vaccine science**, which is also being used for Covid-19, such as that by Inovio Pharmaceuticals, investment journalist Josh Enomoto writes, "The knock against the company is that nucleic-acid based vaccines [DNA and RNA] are unproven. It's the same situation with **Inovio Pharmaceuticals**. Further, in Inovio's case, there may be a risk that its DNA-based vaccine could affect the host's genome. **In that case, it could cause cancer**" (#47.6).

Pharmaceutical companies admit that DNA and RNA vaccines are unproven, have not been large-scale tested on humans, long-term side effects are unknown and they might not even work!

"Despite the unprecedented speed, mRNA vaccines are clinically unproven. No commercially available vaccines use the platform and, until now, it hasn't been tested in large-scale human trials. With COVID-19, that's all set to change" (#47.7).

"General optimism" for Experimental Vaccines They Know Little About

In an ABC news article, we are told that Pfizer/BioNTech and Moderna's Covid-19 vaccines "*might* protect us from the flu". Also, "Even though there's plenty we don't yet know about the vaccines, such as long-term effects, experts are *generally optimistic* by these interim results" (#47.8). Worse still, many doctors say, if governments determine that Covid-19 gene-based vaccinations become mandatory what effect will altering the building blocks of the human race have on future

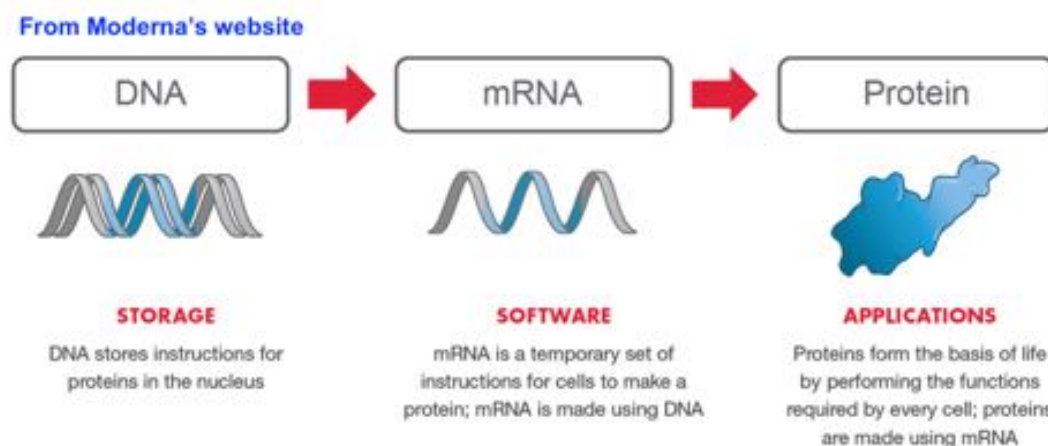
generations? Also, on November 10, 2020, National Geographic published an article that pointed out Pfizer/BioNTech had not released complete vaccine test results, nor had their unpublished results been peer reviewed, even though the vaccines were already in the UK and ready to be distributed throughout the population.

“The lack of data is very concerning,” adds Peter Doshi, associate professor of pharmaceutical health services research at the University of Maryland School of Pharmacy (#47.9). Journalist Whitney Webb writes: “Pfizer’s history of being fined billions for illegal marketing and for bribing government officials to help them cover up an illegal drug trial that killed eleven children (among other crimes) has gone unmentioned by most mass media outlets” (#47.10).

As for Moderna, its vaccine formulations are a corporate secret (#47.11). Thus, only a relatively few people at the top of the American pharmaceutical and biotechnology company know what is being injected into millions of people worldwide – that is of great concern to many doctors.

RNA Vaccines Described as Computer Operating Systems

Moderna and Pfizer/BioNTech are both pioneering experimental mRNA technology and openly admit their gene therapies are not like traditional vaccines at all. Moderna’s website describes its **mRNA technology platform** similar to that of a medical device. Only they describe it as resembling a **computer operating system** that “has been designed so it can plug and play interchangeably with different software”. In the case of the Covid-19 vaccine, the **software program** is the genetically modified mRNA coding that has the function (**application**) to produce alien spike coronavirus-type proteins in the human body.



Moderna acknowledges that creating mRNA vaccines is complex and challenging in order to **get the mRNA into the targeted tissue and cells while evading the body’s natural immune system** (#47.12). Tal Brosh, head of Infectious Diseases Unit at Samson Assuta Ashdod Hospital says “... it is more like a USB device (the mRNA) that is inserted into a computer (your body). It does not impact the hard drive of the computer but runs a certain program”. He also acknowledges there are “unique and unknown risks to messenger RNA vaccines, including local and systemic inflammatory responses that could lead to autoimmune conditions” (#47.13).

Dr Lee Merritt is a former president of the Association of American Physicians and Surgeons (AAPS). She is also a former military doctor. She describes RNA/DNA “vaccines” as **“experimental biologics not vaccines**. They are the biological equivalent to a computer chip you put into a 3D printer then you tell it what to print out” (#47.14).

An article by Dr Eugene Gu in The Independent is titled, “This is the hard-to-swallow-truth about a future coronavirus vaccine (and yes, I am a doctor)”. The sub heading is “The one you’re all getting excited about carries some serious risks” (#48.1). Dr Gu writes: “At that point, it will be hard to convince conspiracy theorists and anti-vaxxers that a self-amplifying messenger RNA vaccine is not an artificially created self-replicating virus... **There are unique and unknown risks to messenger RNA vaccines**, including the possibility that they generate strong type I interferon responses that could lead to inflammation and autoimmune conditions”.

The Matter of Intellectual Property Rights

Among others, Mike Adams explains that the business model of software companies is centred on **intellectual property**. In the software industry these companies own their code. In Big Pharma, they own the molecules they produce. That is why they have always had to synthesise molecules, because natural molecules cannot be patented and therefore cannot make much profit. And so, as an mRNA vaccinated person goes through life, *with their cells constantly being renewed using the mRNA coded strands provided by Moderna*, it would mean those cells are legally the intellectual property of Moderna and Moderna can do with them what they like. The company could, for instance, update their computer operating system or software functioning in a person’s own body without that person having any knowledge of what this actually means for them.

Mike Adams continues, “Basically Moderna will turn you into an operating system and infect you with their malware that hijacks your cells to produce alien proteins that leads to infertility or death [in maybe 50% of cases]”. He explains how serious ethical and legal questions are being asked by many concerned people who have realised this. “Moderna has patented their software (the mRNA strands) that are to be injected into us. As millions of people are being injected with these vaccines, Moderna is creating a medical intellectual property infrastructure where they could [potentially] claim patent ownership over these people” (#48.2).

Explains medical journalist Del Bigtree, “These mRNA vaccines don’t incite your immune system to create antibodies against the disease. They incite your cells to create the illness inside your body!”

When researching how effective the CDC was at gathering data on vaccine injury and death, Del Bigtree was shocked to learn that less than 1% of vaccine adverse events are reported to the Vaccine Adverse Effects reporting System (VAERS) and only 0.08% of deaths (#48.3). This is confirmed by J.B. Handley, author of ‘How to End the Autism Epidemic’. Part of the reason is because VAERS is a passive surveillance system that relies on the willingness of individuals and professionals to submit reports voluntarily. VAERS has been condemned in a British Medical Journal article as “nothing more than window dressing, and a part of U.S. authorities’ systematic effort to reassure/deceive us about vaccine safety” (#48.4). The VAERS equivalent in the UK is the Yellow Card Scheme.

The Dangers of Coronavirus Vaccines

Doctors have warned there has never been an effective coronavirus vaccine for decades. There are reports that years ago tests on ferrets at first seemed successful, as they did develop antibodies, but when these animals came in contact with a wild coronavirus sometime later, a severe immune response caused a cytokine storm and they died.

The scientists concluded that the ferrets did develop antibodies but they were the wrong type of antibodies. They were not neutralising the virus, which is what they wanted, they were developing “binding antibodies” that made the disease stick to the receptors, which is much more dangerous than if a person did not have the vaccine. A number of children died in a similar test about 10 years ago (#48.5). Molecular biologist and immunologist, Professor Delores Cahill explains how this will lead to large numbers of people dying, after having had the vaccine and then being exposed

to a wild coronavirus at a later stage. Professor Cahill, along with many other medical practitioners, are concerned that these deaths will be falsely attributed to the novel coronavirus instead of the vaccine (#48.6).

In his January 4, 2021, health report, food scientist Mike Adams makes a similar statement: “The vaccine primes the immune system to have a hyper inflammatory reaction if it is subsequently exposed to wild coronavirus strains... The population is about to take a nosedive. Those deaths will be blamed on Covid, not the vaccine” (#48.2).

Dr Lee Merritt agrees. **“This ‘vaccine’ will tell every cell in your body to create this spiked protein. This actually creates this antigen in your body, so that it is carried into every cell! Now if you challenge the body with the virus you are supposed to have been immunised against, the vaccine-stylised immune response will not attack the virus *it will attack your body’s own cells*”** (#47.14).

Mandatory Vaccinations = the Crime of Uninformed Consent

Uninformed Consent is described thus: “The use of unwilling persons for medical experiments has a long history. From the classical vivisection of condemned men to the infamous Tuskegee syphilis study and Nazi experimentation on Jews during World War II, patients have been unwittingly used as research subjects 1–3” (#48.7).

Forcing anyone to take this vaccine is a case of uninformed consent. In the UK, **one group pushing for informed consent is the UK Medical Freedom Alliance (UKMFA)**, which is run by a team of medical professionals, academics, scientists and lawyers, aided by a growing panel of experts in the fields of science and medicine (#48.8).

Dr Michael Yeadon is the former chief scientific advisor of Pfizer and he makes it very clear that no person should ever be coerced or mandated to take the Covid-19 vaccine and that it is illegal under international law. No government has the right to override that law. He explains that very vulnerable people should be able to have the vaccine, “but no one else needs this thing... you don’t need to vaccinate a population because one in a million might die from something... you can offer people the vaccine but informed consent is important. ... something very smelly is going on here ... something odd” (#48.9).

Journalist and activist Spiro Skouras reports: “No one should be forced to take a medical procedure. It is called uninformed consent and Nazi Germany was convicted of this crime in the Nuremburg trials after WW2 ... **Pfizer has a lengthy criminal record and civil violations that has paid out billions of dollars in damages for crimes including safety violations, corruptions, bribery and false claims.** Pfizer also has no idea how the vaccine will react with other drugs and medications and are still working on the list of potential adverse event outcomes ***subject to change***” (#48.10; #48.10.1; #48.10.2). On the positive side, for Pfizer at least, the company will be pulling in \$15 billion in revenue from its Covid vaccine in 2021 alone (presumably to be doubled every year with follow-up shots – forever). And who is paying out all this money? The governments of the world from the public’s purse (#48.11).

Alexandra Henrion Caude, a geneticist/scientist from France, quotes an Abstract that lays out potential risk factors of the vaccine in a paper titled ‘Informed Consent Disclosure to Vaccine Trial Subjects of Risk of COVID-19 Vaccines Worsening Clinical Disease’. It states: “The specific and significant Covid-19 risk of adverse drug event (ADE) should have been and should be prominently and independently disclosed to research subjects currently in vaccine trials as well as those being recruited for the trials and future patients after vaccine approval, in order to meet the medical ethics standard of patient comprehension for informed consent.”

Says Professor Cahill, “There is a moral, legal and ethical obligation on health professionals and scientists and regulators and politicians that people are not given interventions that cause them more harm than good and they need to be fully informed” (#48.6).

Spirou Skouras explains, “This is an experimental vaccine that has not yet received official approval by regulators, because Pfizer’s vaccine has only received Emergency Use Authorisation and the trials are still ongoing. That makes this an experimental vaccine... and the public are guinea pigs” (#48.10).

mRNA Science Already Failing Predictions

Thousands of doctors are horrified at the thought of an untested, controversial, experimental and invasive mRNA delivery system coronavirus vaccine that could genetically modify a person’s DNA. This even includes pro-vaxxers such as Dr Paul Offit, MD, Director of the Vaccine Education Center in Philadelphia. Dr Offit said he would not take the vaccine unless he first reviewed the science. Also, he is astounded that 2/3 of the American public would take it (#49.1).

Dr Andrew Wakefield warns: “Once you have injected this, there is no going back. **Once you have put this autonomous replicating mRNA into a cell that can allow it to produce proteins within human cells, you cannot switch it off. If that protein turns out to be analogous to some human protein which induces an autoimmune response, that’s it. It is terrifying ...** Eventually the vaccines will become known to be dangerous. Autoimmune and neurological accumulation of death and injuries will occur, but the powers that be will cover it up for a long time” (#49.2).

Dr Wakefield made this announcement back in December 2020. It is now (at time of writing) early February 2021 and doctors are already seeing proof of these dangers, as shown below.

Professor of Neurology at the University of British Columbia, Dr Chris Shaw, has voiced concern that the Pfizer and Moderna vaccine’s lipid constructs are not being restricted to the muscle injection site, as expected, but are already being found in different parts of the body, which was not what the mRNA science predicted. The initial results from these vaccine trials appeared to protect a person against the virus, but now vaccine components are turning up in the brain, bone marrow, colon, lymph nodes, heart, ilium, kidney, liver, lung, rectum, spleen, stomach, testes and other places. This proves this experimental vaccine is not breaking down as it should be. Originally doctors and scientists claimed this type of vaccine was too small and too fragile and needed to be kept frozen at -70C until administered, thus it was impossible for it to be robust enough to cross the blood-brain barrier. This has now proven not to be the case (#49.3).

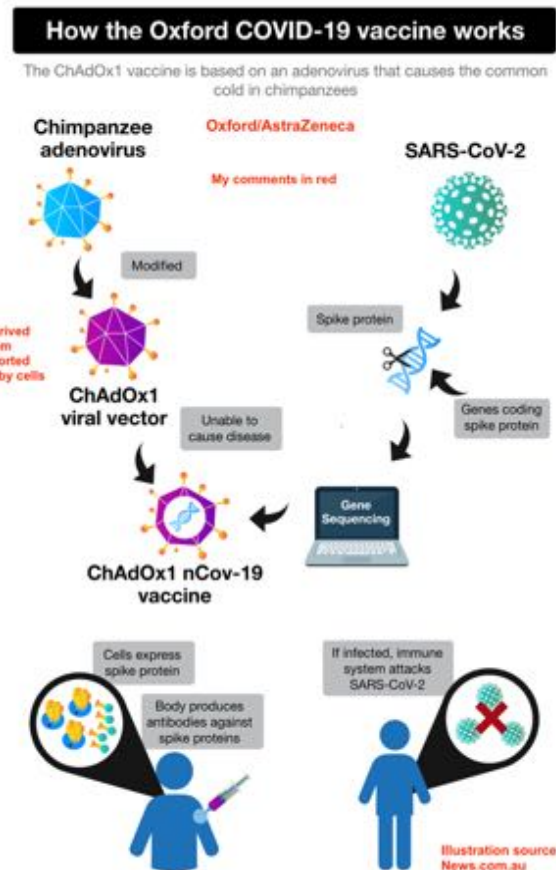
Viral Vector Vaccine - AstraZeneca

AstraZeneca is not an mRNA vaccine, rather it is in the DNA adenovirus viral vector group of vaccines. It works by genetically re-programming a chimpanzee adenovirus (a cold-like virus) to express the coronavirus’s spike protein on the surface of itself. Like mRNA vaccines, AstraZeneca also aims to make the body produce its own vaccine by churning out copies of spike proteins. However, unlike mRNA technology, the virus is modified so it does not program the cells to continue self-replicating (#47.11). Essentially a Trojan Horse is presented to the immune system (#49.3.1).

This DNA vaccine works by carrying a spike protein gene, spliced into RNA, that has been added to the genetic material of a modified chimpanzee cold virus, which then enters into the cell with genetic instructions for the body to produce a SARS-CoV-2 virus spike protein (#49.4). **Johnson & Johnson is also a DNA viral vector vaccine.** “The Johnson & Johnson vaccine uses DNA and a modified, weakened version of a [monkey] cold virus to gain entry into human cells” (#49.5). Both these vaccines contain foetal tissue from aborted babies (#49.5.1).

This transfer of tissue or cells (used in virus vector vaccines) from animals such as monkeys, horses, birds, mice, dogs, bats or birds into a person's blood (xenotransplantation) is not without danger, **because any number of unknown animal viruses could also be injected into the human body.** This, virologist Dr Judy Mikovits explains, is the reason we see an explosion of many diseases today, such as autism, cancer, chronic fatigue, Parkinson's, Alzheimer's and other diseases (#49.6).

In an October 2020 article in a medical journal, titled 'Pros and Cons of Adenovirus-Based SARS-CoV-2 Vaccines', the writer says: "Should we go 'all in' on an Ad-based (adenovirus) vaccine against SARS- CoV-2? The first issue is safety... **Current criteria limit the window to identify adverse reactions to 2 months...** However, the number of monkeys used in preclinical studies is **too small to provide robust safety evaluation...** **If phase 3 trials demonstrate** that Ad-based vaccines are safe and efficient, I will be in line with my shirt sleeve rolled up" (#49.6.1).



When a vaccine drug trial is dealt with a major setback, as was AstraZeneca in September 2020, their shares instantly plummet. In the case of the **University of Oxford/AstraZeneca' vaccine**, which has little vaccine experience, 600 of the 1000 participants suffered mild to moderate side effects, with two people suffering serious inflammation of the spine that can lead to bladder problems, muscle weakness, pain and paralysis (#49.7; #49.8). Immediately, errors became evident in the vaccine trials and cover ups were discovered. "What we have with AstraZeneca is a company that is not straightforward, that cannot be relied upon," Philippe Lamberts, a Belgian member of the European Parliament, said in a radio interview with the BBC on Wednesday" (#49.6.2). One person died. But even if the majority of these people do not suffer immediately, and some of these casualties do recover, it is simply not possible to claim a drug is safe after only a few weeks, or even months, of being vaccinated. That is why, "The traditional vaccine timeline is 15 to 20 years", to assess the long-term true effectiveness and safety of a vaccine (#49.8.1).

Some of AstraZeneca's Dangerous Ingredients

Pharmacist Sandy Lunoe explains that the **AstraZeneca** vaccine contains **el histidine**, which naturally occurs in the body. However when it is injected, the immune system cannot differentiate between naturally occurring el histidine and that present in the vaccine. What may follow is a cascade of autoimmune reactions. The vaccine also contains **polysorbate**. When injected, this compound increases permeability of the blood-brain barrier. This facilitates the passage of other ingredients through the barrier into the brain tissue (#49.8.2). Nevertheless, the FDA has taken the unprecedented step of requiring Covid-19 vaccine manufacturers only three months before declaring a vaccine safe enough, through the Emergency Usage Authorisation law, to inoculate

whole nations and millions of people! Here are just a few comments that have made it into the news:

“Vaccine development is proceeding at a pace never-before-seen in the history of medicine ... In some cases, they are also harnessing technologies that have never been used in approved vaccines ... **the science is hurtling forward so fast and bending so many rules about how the process usually works that even veteran vaccine developers do not know what to expect...** Meanwhile, the difficult laboratory science, such as animal testing is, in many ways, being leapfrogged or running in tandem with testing in people... These trials seem designed to prove their vaccines work, even if the measured effects are minimal... Covid vaccine shots won't be ‘a walk in the park’”.

This means that no one has any idea of what the long-term side effects could be, such as increased cancers, mutant genes, infertility, increased autoimmune reactions and many other serious conditions. Nevertheless, some doctors are reporting that these vaccines are perfectly safe.

Doublespeak and Conflict of Interest from Governments and Scientists

One such doctor, trying to quell the groundswell of doubt about their safety and calls to boycott the vaccines, is Professor Jamie Triccas, head of infectious diseases and immunology at the University of Sydney. Professor Triccas assures the public that the vaccines have passed “robust” efficacy trials and there have been no shortcuts. This is in spite of the fact that 190 vaccines are on the table in only a few months using five different types of technology and this situation, he admits, “is completely unprecedented” (#49.9). Another doctor assuring us that Covid-19 vaccines are safe is the Chief Executive of the UK Medicines and Healthcare products Regulatory Agency (MHRA), Dr June Raine. On closer examination, however, the MHRA, which fiercely calls itself independent, is, in fact, a government organisation funded by Big Pharma (#49.10). (Conflicts of interest with regard to Covid-19 are everywhere.)

After insisting that “no corners had been cut” and “The safety of the public will always come first in the approval process”, Dr Raine also states, “**We still do not know how Covid-19 interacts and behaves with medicines or medical devices used for existing conditions**” (#49.11). This demographic, however, must surely count for a very large percent of the population!

According to Professor Triccas, all the processes have been achieved in record time, because governments and investors were prepared to throw a lot of money at the research. But does a lot of money speeding up the process at the expense of large scale, long-term studies equate to safety, especially when clinical trials have excluded participants who fit a number of criteria?

Drug Trials with Healthy People Don't Translate to Entire Populations

In the case of the **Novavax** vaccine trials those excluded from participating includes, but is not limited to, people who have (for a period of time) received blood products, been on immunosuppressant medications, have a history of allergies, are pregnant or breastfeeding, receiving cancer treatment, suffer bleeding disorders, are drug or alcohol dependent, have cardiovascular, neurological, respiratory, psychological, auto-immune diseases, who suffer migraines, nerve compressions, and a list of other health conditions.

Also, before, during and after the clinical trials, participating women of child-bearing age had to agree not have to have sexual intercourse, or they had to use contraceptives (#50.1). No doubt because any resulting miscarriages or genetically deformed babies will throw a spanner into the works if pharmaceutical companies are to get these vaccines out in record time.

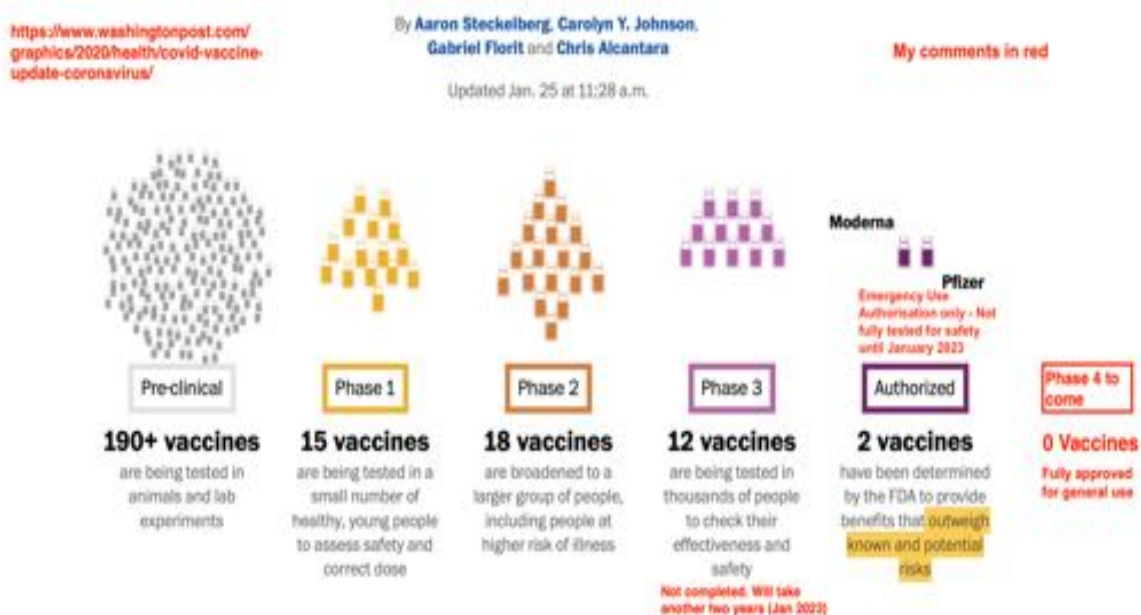
In other words, **how is it possible to be confident that “robust” trials conducted over only a few weeks with healthy, young participants have rendered a drug (190 drugs?) safe enough to vaccinate the world**, numbering billions of people, of various ages and with all manner of health problems and taking any combination of medications? And with reports that new strains are already emerging, how will any vaccine be able to protect anyone? (This is why Bill Gates has said all people will need to be continually vaccinated – *because Covid-19 is never going to go away.*)

After all that has gone on since 2020, we need to ask ourselves. Are we really ready to trust governments and Big Pharma with our lives? Mike Adams says: “There is no court in the world that will ever deny the power of the corporation, because the governments are nothing but extensions of the corporate monsters that rule our world. The US Senate is an extension of Big Tech. The FDA is an extension of Big Pharma. The lawmakers are an extension of the Military Industrial Complex. The corporations run everything” (#47.5).

Says Dr Johan Denis, medical doctor and homeopath from Belgium: “Big Pharma and the vaccine industry have the model of organised crime. They cover up research results, conceal side effects of their toxic medicines. They bribe doctors and professors, sponsor universities, infiltrate continuing education and regulatory commissions, corrupt patient organisations, and defraud journals and editorial boards with ghost writers” (#49.8.2). Also, just who are these investors who are assured to continually make staggering profits from these vaccines in record time?

Rigged Vaccine Trials

There are reports that the drug trials for Covid-19 vaccines were rigged. Instead of the 30,000 to 60,000 participants normally required for Phase 3 of a vaccine trial (over several years), which the manufacturers agreed to at the beginning, closer reading of the protocols shows this was unlikely to ever have been their intention. For example, Dr Lee Merritt speaks of how some vaccines had already been manufactured and were being delivered into countries even before the Emergency Use Authorisation was granted (#47.14)! There is also concern that only 33% of vaccines for infectious diseases make it through Phase 1 of the clinical trials all the way to Phase 4 – fully approved by the FDA. This means that at this point in time, only 33% of the Covid-19 vaccines being rolled out may actually prove to be safe and effective (#41.8). The drug trial phases described below is from The Washington Post (#50.2). My comments are in red.



An October 27, 2020, news report by Dr Joseph Mercola explains how Moderna, Pfizer, AstraZeneca and Johnson & Johnson had whittled down their trial participants to at most 164 people, which is the number required for the initial testing, Phase 1 – the “interim and primary analyses”. **Pfizer’s interim analysis only had 32 vaccine recipients (#50.3)**. As for Moderna, out of its 45 patients who received the vaccine, they only had flimsy data on eight of them, which begs the question of what the status was of the other 37 vaccine recipients ([#41.8](#))? As expected, these companies applied to the FDA – and received – special dispensation under the **Emergency Use Authorization (EUA)** and therefore did not need to complete Phase 3 before rolling out their vaccines.

As the German doctors’ Global Report points out, what about the conflict of interest in that the biopharmaceutical industry provides 75% of the FDA’s drug review budget?

Dr Joseph Mercola explains there is also the matter that the trials did not always use inert placebos (e.g. saline), which is essential for true double-blind testing. Rather, they injected aluminium, meningococcal vaccine and other substances in order to mask the potential side-effect differences between the two control groups (those vaccinated for Covid-19 and those not).

Vaccine Efficacy and Recovery Redefined

Just as the definition of the word “pandemic” was changed by the WHO in 2008 – from worldwide illness and death to worldwide illness only, so too has the word “efficacy” been altered. In 1915, the word “efficacy” was coined to mean the prevention of a disease. Today, however, it means “to prevent the appearance of symptoms”. In this way, it can be claimed a vaccine has 95% efficacy by reducing symptoms but not death. Also “vaccine efficacy” is just a statistical measurement of short-term performance of the vaccine. It cannot guarantee the durability of the vaccine beyond the time frame of experimentation, which is only a few months in these cases” ([#50.4](#)).

The public, of course, does not realise this. This has also happened with the word “recovery”, since the vaccines have been rolling out. The dictionary meaning “to recover” is to “**regain** health after being sick or injured”. However, as the German doctors have stated: “Fauci redefines ‘recovery’ to include people partially disabled and living at home on oxygen”. This means to pass the 70% efficacy required for a vaccine, the manufacturers do not actually have to claim it will prevent serious Covid-19 complications or death, just a reduction in symptoms, such as fewer coughs or headaches.

“When it comes to the COVID-19 vaccine, shockingly, preventing infection is not a criterion for success in any of these trials. **The only criterion for a successful COVID-19 vaccine is a reduction of COVID-19 symptoms, and even then, the reduction required is minimal.**” And for those who think unvaccinated people will be responsible for transmitting the virus, think again: “People who get vaccinated may believe they can’t spread the coronavirus and could prove to be the next super-spreaders, Harvard University public health student Rushabh Doshi has warned” ([#50.5](#)).

Reports Forbes magazine in an article ‘Covid-19 Vaccine Protocols Reveal That Trials Are Designed To Succeed’, “**It appears that these trials are intended to pass the lowest possible barrier of success,**” ([#50.6](#)).

Korean Medical Association Urges Government to Halt Vaccine Program

Moderate or serious side effects suffered by some vaccine volunteers (such as multiple sclerosis, transverse myelitis and other reactions that interfere with daily life) were common in trials. Also, a number of deaths from the vaccines were already being reported back in October 2020. In South Korea, for example, 59 people died in the country’s state run vaccine program. This was not reported in the local news or mainstream media, it was only uncovered by a Singaporean news agency. This fatal adverse event was to two locally manufactured Covid-19 vaccines, **SKYCellflu**

Quadrivalent and Sanofi's **VaxigripTetra** (both protein subunit vaccines). The Korean Medical Association urged the government to halt the inoculation program, but it refused to do so (#50.7, #50.8). There were also reports in January 2021 of 55 people dying from the vaccine in the US, and 33 in nursing homes in Norway (#50.9, #50.10). And this was just the beginning.

It really is important for people to know what type of vaccine they are being offered and to be informed of its potential side effects in order to make a decision. Only two months into the vaccination program in the West and thousands of people are uploading onto the internet how they had no idea what they were doing and are now suffering the consequences.

In fact, I began to compile a list of Covid-19 vaccine injuries and death (with video and article links) in the first few weeks after the roll out but have now given up because there are so many of them: '24 Residents Dead in 3 Weeks After Covid Injections'; 'Seniors are Dying Like Flies After Covid Injections'; '53 Dead in Gibraltar in 10 Days After Experimental Pfizer mRNA Covid Vaccines Started'; '10 Dead with 51 Severe Side Effects (Germany)...' (#50.11). I find it interesting how much "concern" governments were emphasising to protect frail elderly people in care facilities from catching Covid-19, even preventing visits from healthy family members for months on end. Nevertheless, these same governments have no problem to vaccinate the same elderly people and if they die a few days later, well, we are told, people die in care facilities all the time!

Subunit Vaccines work "in Theory"

Novavax is a **protein subunit** vaccine type. This is similar to mRNA and viral vector vaccines in that it causes the body itself to create SARS-CoV-2 spike proteins in its cells. In this process "Novavax produces the spike proteins using moth cells, and then studs them on a nanoparticle, creating a shape that looks much like the spike-covered virus. These proteins harpoon themselves into a person's cells, along with a dose of the company's adjuvant [i.e. the sap from a tree that causes a massive autoimmune response] to trigger the immune system. **In theory, immune cells should be able to spot and attack these nanoparticles, as they look just like little viruses**" (#50.12).

In Novavax's history, it has had two failed vaccine trials in recent years, which led to the company's stock plummeting and the close of two manufacturing plants and the dismissal of 100 staff. In its near 30-year history it is yet to develop an approved vaccine. Nevertheless, Novavax is aiming to produce two billion doses of Covid-19 vaccine in 2021 and have it rolled out across Australia and other countries under the Emergency Use Authorisation, *before the vaccine's safety record can be known*. What makes it surprising, writes one journalist, is that 20-year-old Novavax, which has never produced a vaccine that has reached the public before, made it to late-stage clinical trials so quickly (#50.13). Having received \$1.6 billion funding from the US Federal Government, its stocks have soared 2000% (#50.14).

Novavax's "selling point" is that it is not an RNA or DNA vaccine, which many people refuse to take. This is correct. However, anything that puts this spike protein "bioweapon" into your body (including Novavax) will potentially produce prion diseases, so the result is the same even if the technology is not. Prion diseases are a group of rare neurodegenerative disorders that lead to a progressive decline in brain function and death (e.g. mad cow or Alzheimer's diseases, over time (#50.15).

As with any drug or medical intervention, all these vaccines carry risks that need to be assessed. I had to do this with regard to my own health concerns when researching various cancer treatments. In my case, however, I was not being pressured by anyone as to what decision I should make, as informed consent was encouraged. This is not what is happening with Covid-19 vaccines, as bullying, ridicule and guilt trips are being instigated by the media against those who dare to question them.

Adverse Events from Vaccines being Censored by Big Tech

Any information that shines a bad light on these vaccines is generally being withheld by governments and the corporate media. However, thanks to a growing number of leaked reports to alternative news sources and videos being uploaded onto various media platforms, more and more of this information is being circulated in independent circles. Case in point, on December 20, 2020, independent media The Epoch Times ran an article ‘Thousands Negatively Affected After Getting COVID-19 Vaccine’. On one day alone (December 18, 2020), a CDC working document reported that 3150 people out of 112,807 vaccinated (2.8%) suffered a Health Impact Event so severe they were described as being **“unable to perform normal daily activities, unable to work, required care from doctor or health care professional”** (#51.1; #51.1.1; #51.1.2; plus 12 video links).

As for the UK, the Medical and Health Products Agency (MHPA) is so concerned the health system will not be able to handle the flood of people who will suffer Adverse Drug Reactions (ADR) from these vaccines that in November 2020 it placed an advertisement for an AI system capable of processing this information to prevent bottlenecks (#51.2). And no wonder, as Britain’s National Health Service confirmed on December 9, 2020, that it will have to deploy “resuscitation facilities” in coronavirus vaccination centres after a number of healthcare workers suffered anaphylactoid reactions after receiving the Pfizer/BioNTech vaccine on the first day of rollout (#51.3.1).

Fast forward to January 24, 2021 – only a few weeks after the vaccine was rolled out in the UK – and the MHRA Yellow Card Scheme has stated that **an estimated 5.4 million doses of Pfizer and 1.5 million doses of AstraZeneca had been administered. And the reported adverse reactions with Pfizer is 49,472 (0.9%) and 21,032 with AstraZeneca (1.4%)** (#51.3.2). Like VAERS in the US, this is a passive reporting system that only receives a fraction of the total number of vaccine injuries and deaths. Tragically, but not unexpectedly, distressing videos of sufferers are now being uploaded on the Net showing people collapsing dead within minutes of being vaccinated, and injured people suffering whole body convulsions. Others are devastated with the effects of Bell’s palsy just days after receiving the Covid-19 vaccine (#51.1). Fortunately, these videos have been uploaded onto alternative video platforms not controlled by Big Tech, which is taking these reports down.

What is more, in every case the vaccine companies are either unavailable for comment, have dismissed these reactions by claiming they are not associated with the vaccines, or conduct their own investigations. For example, in the tragic case of the healthy 56-year-old Florida obstetrician, Dr Gregory Michael, who died two weeks after receiving the Pfizer vaccine, this is not being investigated by independent authorities, but by the CDC and Pfizer (#51.4)! That, says corporate fraud lawyer and medical inventor Dr David Martin, is like asking a bank robber to investigate his own bank heist (#47.2). This is hardly a surprising outcome, when we think that through Operation Warp Speed, the US government has invested nearly \$11 billion to speed up the development of vaccines and jump-start manufacturing **before research is finished** (#50.2).

Regarding Dr Michael, he was healthy and fit and with no medical conditions. Nevertheless, Pfizer claims his death had no direct connection to the vaccine (#48.4). This response from vaccine manufacturers – that deaths and injuries experienced within minutes, hours, days or weeks of a person being vaccinated is either a “coincidence” or “unrelated” – is standard.

In other words, it is absolutely not in the financial interest of governments nor vaccine corporations to inform the public of injuries and deaths attributed to the vaccines. Writes Dr Gu, “When it comes to the United States and its private healthcare system, pharmaceutical companies have a long and sordid history of putting profits over people and human lives” (#48.1). And as Dr Lee Merritt summed up, “If you tell people the truth [about Covid vaccines], the \$69 billion vaccine

industry will fall to zero in an instant” (#47.14). This cover-up is only possible if the mainstream media is on side, which it is, because it is owned by Big Pharma.

Rushed Science is a Recipe for Disaster

The American biotechnology company **Moderna** is set to make billions of dollars in profit from Covid-19 vaccines. Yet, as corporate lawyer Dr David Martin explains, Moderna was started as a chemotherapy company for cancer not a vaccine manufacturer for SARS. It has never before produced vaccines or medicines for humans. “If we were going to say we are going to give people prophylactic chemotherapy for the cancer they don’t have you’d be laughed out of a room, because it is a stupid idea. But that is exactly what this is. It is a mechanical device in the form of a very small packet of technology that is being inserted into the human system to activate the cell to become a synthetic antigen (virus) production site.

Big Pharma is using emergency authorizations to force untested gene therapies onto the population under the guise of mass vaccinations” (#47.2).

The German doctors, in their Global Report 2019-nCov Summary of Facts, state numerous and glaring conflicts of interest between governmental bodies and pharmaceutical companies, such as the National Institute of Health (NIH) owning half of Moderna’s vaccine industry.

Putting together the huge profits involved for Big Pharma, the governments driving Covid-19 vaccination programs on their people, zero accountability for the vaccine manufacturers and the rushed science to get the drug ready and distributed as soon as possible and, as many, many critics state, it is the perfect business model – and a recipe for disaster. This is evidenced by the German doctors’ Global Report (Revision 9.9.3, pg 50) that, with regard to the clinical trials of Gilead’s experimental Covid-19 drug **Remdesivir**, “Fauci redefines ‘recovery’ to include people partially disabled and living at home on oxygen”. And “Remdesivir clinical trials published in The Lancet finds no benefit and very serious side effects.”

This has not stopped the NIH being proud of the fact that by relying on SARS research from 2000, they were able to reduce the time it takes to normally develop a vaccine against a new infectious agent from 10 years to 66 days! Writes Dr Francis Collins, the Director of the NIH, “**Literally within days, they had created a vaccine in the lab**” (#51.4.1). Writes National Geographic:

“COVID-19 vaccines have reached consumers in record time. Though the process can typically take 10 to 15 years, the U.S. Food and Drug Administration has granted emergency authorization to vaccines made by **Pfizer and Moderna in less than a year**. Before now, the fastest-ever vaccine—for mumps—took four years to develop in the 1960s” (#49.3.1).

Furthermore, experimental gene therapy is going to be the way of “vaccines” in the future. Why? Because they are quick to produce and therefore cheaper to make. Traditional vaccines involve five stages of production taking a minimum of 10 years and at a cost of \$500 million (#51.4.2).

Also, gene therapies are fully synthetic and don’t rely on living cells, and self-amplifying mRNA, which makes copies of itself once delivered to the cells, means the dose can be much smaller. In other words, much greater profits can be made at a vastly reduced cost in a much quicker timeframe. As for the “small” matter of how genetically modifying the entire human race will affect the citizens of the world and future generations, this is still in its experimental stage. Or is it? In Chapter 5, I show that those at the top of the power pyramid have been planning this for decades with a very specific agenda in mind.

The Vaccine Injury Act of 1986

People injured by these vaccines (and after only a couple of months of vaccine roll out that number has already reached tens of thousands and is growing), they will get no compensation from the pharmaceutical companies involved. This is because vaccine manufacturers are exempt from any liability in accordance with the Vaccine Injury Acts of 1986. Thus the only course of action available to these people will be to petition the US Department of Health and Human Services. **As Robert F Kennedy says, by 2025 vaccines will be a \$100 billion industry. It is a goldrush industry constantly driving for more growth and higher profits. Governments that create policies are the gatekeepers to that wealth (#51.4.3).** Politicians have been bought by the pharmaceutical companies. And I would like to add that some have been blackmailed and others are a part of a much bigger agenda playing out here. (Refer Chapter 5.)

These cases are then argued in the US Claims Court, referred to as the Vaccine Injury Court. The pharmaceutical companies do not have to participate, and taxpayers have to foot the bill for any damages awarded. Thus it is left to the injured parties to attempt to sue the US Government acting as a government lawyer with the Department of Justice, with the taxpayers paying for its defence. **With such monumental hurdles to cross, only a small percent of cases make it to court and fewer are awarded compensation.** Even taking into consideration this greatly reduced number of successful claims, \$3 billion dollars has still been paid out to people injured or dying from vaccines between 1986 and 2019. (Refer to 'Vaxxed: from Cover-Up to Catastrophe' banned DVD, and 'Vaxxed 2 The People's Choice' banned DVD #51.5).

In a May 2020 roundtable discussion on Zoom, 165 doctors from around the world put their hands up when asked if they were concerned about the Covid-19 vaccine (#52.1). And it is not only doctors. As Dr Elke de Klerk, founder of Doctors for Truth in The Netherlands stated back in October 2020, 87,000 nurses also did not want to take the vaccine either. Dr de Klerk's Twitter post was deleted, but fortunately someone has reposted it on Bitchute (#8). BOMBHELL FINDING – Added in April 2021

European Medical Regulatory Board Uncovers Fundamental Quality Control Failures of mRNA Manufacturing and Distribution Processes and the Dire Health Consequences.

As explained previously, for a drug to be accelerated through the normal lengthy testing and approval protocols (such as in the case of a national medical emergency) special approval needs to be granted by governmental drug regulators.

In the US that regulator is the Federal Drug Administration (FDA) and the accelerated approval is called “Emergency Use Approval” (EUA). The equivalent process in Europe requires the drug manufacturers to apply to the European Medicines Agency (EMA) Committee for Medicinal Products for Human Use (CHMP). The evaluation process can take up to 210 days, but the CHMP can reduce the timeframe to 150 days if justification can be shown (#52.3).

The January 2021 findings of the CHMP’s accelerated evaluation process for mRNA vaccines has proven shocking, revealing even more dangers inherent in these vaccines.

The European Medicines Agency has published a report stating it is not satisfied with the standard of both the production and distribution processes. This is because Covid vaccine manufacturers have not, as yet, provided any proof to demonstrate the purity of their product from the time the vaccine leaves the production line to the time it reaches the recipient. **The absence of this data represents a significant quality control omission.** This includes the question of sterility of the storage containers (vials), which have not been subjected to any testing protocols, and the purity of the product. In other words, there is no way of knowing if the vaccine injected into a person’s arm matches the “quality” of the product demonstrated in Phases 1 and 2 of the clinical trials.

Refer to link below ‘Interview with Dr Vanessa Schmidt-Kruger’ for the extent of the manufacturers’ deception inherent in the marketing of this product (#52.4). Dr Schmidt-Kruger is a Senior Scientist for Research Group Molecular Cardiovascular Research.

This interview is part of the ‘Hearing #37 German Coronavirus Extra-Parliamentary Inquiry Committee’, launched by Dr. Reiner Fuellmich on July 10, 2020. Dr. Fuellmich LL.M. (UCLA) is an attorney at law, authorized to represent at all courts in the US federal state of California. He has been a consumer protection trial lawyer in California and Germany for 26 years (#52.5).

An article titled ‘Bombshell Interview about Covid-19s Vaccine’ presents excerpts from this interview with Dr Vanessa Schmidt-Kruger (#69.2). Yes, it is very scientific, but most people will get the general gist of the serious failures present in Covid-19 mRNA vaccine procedures and the subsequent dangers.

Covid-19 mRNA Vaccines – contaminations and dangers

“... the BioNTech vaccine that is currently already being used is **not highly purified, it contains contaminants** of certain components.”

“They didn’t conduct any critical scrutiny at all, there are **lots of side effects that were not discussed at all in public**, they also didn’t critically scrutinise what consequences it will have to inject this into people, particularly vulnerable groups who already have certain organ-related complaints, who are especially susceptible to these adverse effects.”

“... **they have had to switch to lower-cost processes**, e.g. using huge quantities of DNA that functions as the substrate to be able to produce the RNA in an in-vitro transcription reaction. This is done via bacteria, via the **fermentation of transformed bacteria that contain this DNA**. The bacteria multiply the DNA in huge amounts, and this **leads to new dangers or risks, particularly contamination.**”

“... needs to now develop and introduce various analysis processes to ensure that the substrate is free of microbiological contaminants – **they probably mean E Coli bacteria** for example. There don’t seem to be any processes to ensure or monitor for that.”

“... if this DNA is not digested well enough, if residues are left, **this harbours risks...**”

“... BioNTech has admitted that **there are DNA contaminants.**”

“... they have no idea whether the vaccine is still viable after transportation.”

“... they **don’t have any proper standard** for the various batches.”

“... It was found that the **integrity** of the RNA **always varies** in the batches that had been made...”

“... the integrity of the RNA means of course the **RNA quality**. They have found that this **is not very high ...**”

“... now they have found new batches with only 55% RNA integrity, i.e., half of it is **basically unviable.**”

“... **the lipid nanoparticles get into all cells, not just the muscle cells – it is an error to believe the latter.**”

“... linearised DNA is optimal for integration....That is the risk. I didn’t really want to get into what can happen if this is the case: **genes can be switched on and off, upregulated and downregulated, cancer can develop** – there are a lot more possibilities.”

“This integration: where it occurs is the nuclear genome – **we can’t control that, it can happen anywhere**. There are sections in the DNA that are **vulnerable** to it, and others that are not so vulnerable. And it is important where the DNA lands. It may land on a gene: then **the gene will become dysfunctional**, the protein will no longer be formed, and if it is an important protein, **the cell may die**, and if this continues to replicate, this **can cause really massive damage**. If for example it lands in an important cell that divides frequently, then clones can arise that are modified, they are gene modified, and in that case in these cloned cells these proteins are no longer produced and then, **in the worst case, there is a loss of function**. If it leaps into genes that have a regulatory effect on gene expression, then the **genes may be switched on or downregulated**, i.e., the output will differ. And this means **the metabolism of the cell will alter**. If this is passed on in replication, then **many things may alter in the body.**”

APRIL NEWS REPORT: Johnson & Johnson – Another Failed Quality Control

Emergent Biosolutions is a little known pharmaceutical company that was granted a major role in producing Covid-19 vaccines by the US federal government. This saw Emergent's revenues skyrocket from \$523 million in 2015 to more than \$1.5 billion in 2020 during the Trump administration. Emergent Biosolutions is producing the Johnson & Johnson vaccines. However, the FDA has cited "problems ranging from poorly trained employees to cracked vials and mould around one of its facilities". **This has resulted in a failed batch containing 15 million doses of the vaccine (#52.6).**

CHAPTER 4: THE DRIVE TO SILENCE TRUTH SEEKERS & FREE SPEECH

Doctors being Silenced, Censored, De-platformed, Threatened and Ridiculed

The individuals in the videos I have sourced come from many countries – Australia, the US, Canada, Bulgaria, Russia, Sweden, Switzerland, Germany, Ireland, The Netherlands, Belgium, Spain, Italy, France, Israel, Argentina, Brazil, South Africa and the UK. These doctors are motivated by a concern for the welfare of their patients and are frustrated by the obstacles that are deliberately being put in their way (#53). Again and again they mention their Hippocratic Oath, to do no harm. Some are still perplexed by what they have experienced, some are still working to join the dots, while others have already figured it out (#54.1).

The links I have selected are from February 2020-March 2021 and a lot has happened during this time for these people to get up to speed with what is going on. When viewing the supplied links, be sure to check the date the video was uploaded. For example, many doctors who were confused and urging open discussion back in April 2020 have since become frustrated and angry by the lack of progress and are openly contesting the Covid-19 narrative months later (#3.1).

Without doubt, what has made the journey extremely difficult for doctors is that even though they have tried to engage with governments and various authorities about their concerns, and have uploaded their experiences online, these professionals continue to be silenced, censored and de-platformed, not just in the mainstream media but also on social media platforms, by Big Tech – in particular Facebook, Twitter, Instagram, Vimeo and YouTube. They are also being discredited and ridiculed in Google searches (as “flat-earthers”, “conspiracy theorists” and “quacks”).

Another Big Tech silencing tactic is to effectively “burn” a person’s index card, so that someone searching Google’s “library” for them has no way of finding them. As such, it can be difficult to track down these concerned and dissident voices in the mainstream media. Check out James Corbett’s excellent video, ‘The Library of Alexandria is on Fire’, explaining how Big Tech is digitally burning down our modern-day Library of Alexandria – the internet – through deplatforming and censoring information for political purposes (#54.2).

*Suggestion: try using alternative **search engines** to Google, such as DuckDuckGo; Bing; Yahoo and Internet Explorer. Alternative **video/content sharing platforms** to YouTube and Vimeo are LBRY.TV; Bitchute.com; Brandnewtube.com; Rumble.com; Minds.com; Odysee.com and D.Tube. And instead of Facebook or Twitter, check out other **social media networks** such as Parler, Gab and MeWe. There are others, too. It just takes a bit of getting used to navigating these less familiar sites (#55).*

Whistleblowers Discredited and Scorned in Fake News

Senior software engineer and **Google whistleblower Zach Vorhies** explains that since 2015, corporate controlled giant Google has been increasingly manipulating information to destroy people’s credibility if they have a powerful counter narrative (in particular, medical or political). This is because they are seen as a threat to Google’s narrative as dictated by its parent corporation’s interests (#56).

A perfect example of this is virologist Dr Judy Mikovits, who has been called “one of the most accomplished scientists of her generation”. Several years ago, Dr Mikovits discovered and exposed the disaster of contaminated vaccines coming through blood supplies with gammaretroviruses. (These consist of a large number of leukemia and sarcoma viruses of mice, birds, cats, dogs, bats, horses, primates and other mammals). These contaminated vaccines have infected tens of millions of Americans (and people in other countries) and it is the reason, she says, we see an explosion of

many diseases, such as autism, cancer, chronic fatigue, Parkinson's disease, Alzheimer's disease and others. As to be expected, negative publicity such as this is a huge problem for Big Pharma (and its shareholders), and thus a Google search on Dr Mikovits directs people to fake news that has destroyed her character and claimed she is a quack. Reports also state she was imprisoned. This is true, but what these "news" sources don't explain is that Dr Mikovits was illegally imprisoned and then released without charges.

Dr Mikovits is a Christian who says she will never compromise and stop telling the truth whatever they do to her. Her story is told to Mikki Willis on the documentary Plandemic Part 1, which has been seen by more than one billion people (#49.6).

Gastroenterologist **Dr Andrew Wakefield** has suffered a similar fate, being struck off the UK's medical register for voicing his concerns – that the MMR vaccine is causing autism in children (#57.1). As investigative filmmaker Del Bigtree explains, doctors are taught nothing about vaccines at medical school, except that they work to keep people healthy. In truth, however, doctors and other medical professionals who *have* looked into the science are shocked at what they have found. (Refer to German doctors' Global Report, the films VAXXED and The People's Choice, and multiple other sources, also Dr Sherri Tenpenny #57.2.)

All these doctors who are being censored by Big Media and Big Tech feel a sense of helplessness for the welfare of their patients, the violation of the patient-doctor relationship by third parties, such as governments that dictate how they are to treat their patients, and the frustration at being unjustly censored and cruelly attacked in the media.

Doctors Who Deviate from Accepted Government Narrative are Shut Down

One leading French infectious disease physician, Professor Didier Raoult, who deviated from the mainstream Covid-19 narrative by using HCQ and getting a 100% success rate, even received death threats. These threats were later traced back to a top scientist linked to Gilead Pharmaceuticals, a pharmaceutical giant that has a huge monetary incentive for the over-the-counter drug HCQ to fail, as it is promoting its own drug **Remdesivir** to fight Covid-19 (#58).

As America's Frontline Doctor James Todaro explained in their Press Conference at Capitol Hill (Pt 2): **"When President Trump promoted HCQ on Twitter early during the pandemic after hearing of its success in France, Gilead's stock plunged 8.7% within hours and continued to fall in the following week, erasing \$21 billion dollars from Gilead's market cap"** (i.e. stock value; #59.1).

Another doctor who has deviated from the mainstream Covid-19 narrative is Dr Pierre Kory in the US. Dr Kory, who is board certified in critical care, pulmonary diseases and internal medicine, is speaking on behalf of a group of highly esteemed medical researchers with almost 2000 peer-reviewed papers between them. This group came together early on during the Covid-19 crisis to work out how best to treat patients. As a lung specialist in the ICU at Aurora St Luke's Medical Center, Wisconsin, Dr Kory has only been treating Covid-19 patients since the outbreak began.

Dr Kory is frustrated beyond measure that the NIH, CDC and FDA refuse to review the immense body of new scientific data compiled by this team of researchers that proves the 45-year-old medication Ivermectin is a wonder drug in preventing and treating Covid-19 when used in the first seven days of onset. **Ivermectin is a prophylactic treatment. (Like HCQ), if you take it you will not get sick with Covid-19,** says Dr Kory. Ivermectin won a Nobel Prize in 2015 for ridding the world of parasitic diseases. Studies show it has immensely potent antiviral and anti-inflammatory properties.

In this video Dr Kory delivers a passionate testimony during the Homeland Security and Governmental Affairs Committee on ‘Early Outpatient Treatment: An Essential Part of a Covid-19 Solution, Part II’ (#59.2). He is visibly distraught that most of these patients are dying after having suffered for weeks. By the time they get to the ICU, he says, it is too late and he can’t do anything to help them recover. He explains how these patients are all from the most disadvantaged communities – Blacks, Hispanics and Asians. He simply cannot understand why he and his fellow medical researchers have been shut down and silenced by government departments and the law.

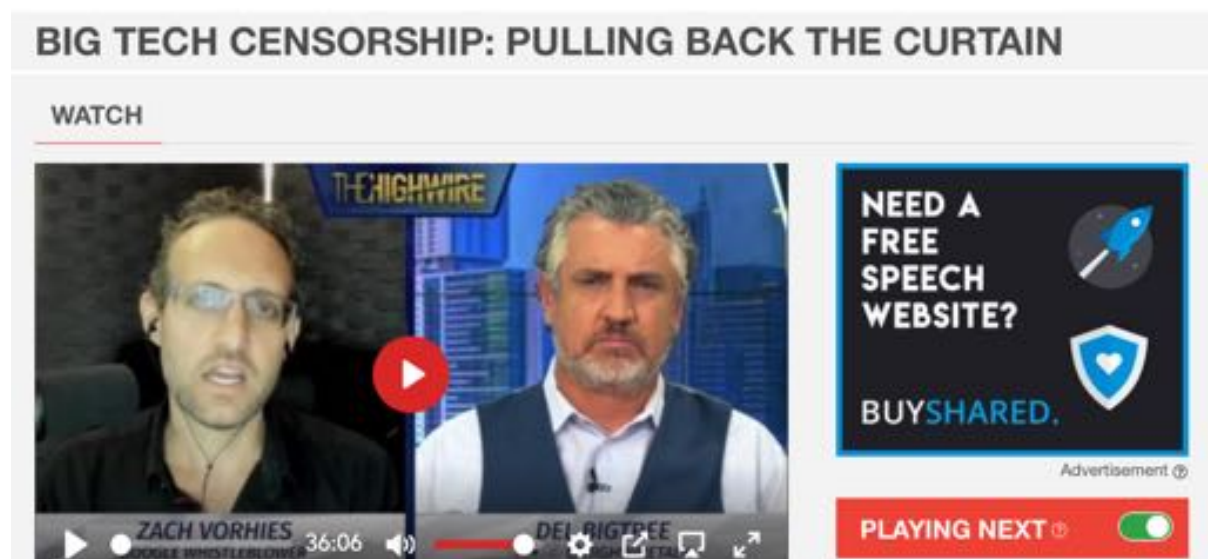
Dr Richard Bartlett, interviewed on America Can We Talk in July 2020, came to the same conclusion months earlier about using Ivermectin to treat Covid-19 patients. He explained that Ivermectin, hydroxychloroquine and inhaled steroids (Budesonide, sold under the name Pulmicort) are the best way to tackle coronavirus. He was visibly overflowing with enthusiasm and hope during the interview because of the success of these drugs (#59.3). *However, within days, this YouTube video was “removed for violating YouTube’s Community Guidelines”.*

One month later, in August, 2020, Australian gastroenterologist Dr Thomas Borody, who developed the drug Ivermectin, also argued for its use as an effective cure for Covid-19. “‘I wrote to the federal and state governments’, he told the newspaper. ‘I wasn’t even responded to’”. And despite the drug’s proven safety record and promising results in preventing Covid-19 and quelling its symptoms, the government in Australia — and the US — refuse to consider Ivermectin, even though they still do not have a curative plan. “It’s all about lockdowns and vaccines” said Dr Borody (#59.4).

CHAPTER 5: A MUCH BIGGER AGENDA BEING PLAYED OUT

The WEF's Great Reset Roll-Out Agenda

The World Economic Forum (WEF) has a pivotal role in the specific darkness that began descending on our world in 2020. This private organisation is by no means the only power influencing drastic changes to our world's systems, but it has managed to position itself as the central body over the Great Reset and the "oracle" for what is ahead. This is revealed by the WEF's meticulous response to the Covid-19 pandemic, which has been a coordinated effort at the highest level in place *long before* the first Covid-19 case appeared in December 2019.

The 3000 WEF participants in Davos, Switzerland, in 2020, have hailed the appearance of Covid-19 as a "unique opportunity to re-imagine the foundations of our society, technology, economy, health system and much more", with their comprehensive plans laid out on their website. In what they are calling 'The Great Reset', humanity "will enter uncharted territory". Says investigative journalist James Corbett, **"The Great Reset is a propaganda marketing roll-out campaign for a rebranded and renamed New World Order with lipstick"**.

Says Alex Jones, **"We are now in a post-Industrial world. The global elite have seized control of the world and are about to enforce their New World system in all nations"**. Furthermore, this "super-class" are no longer being secretive about it, as seen in The Great Reset front-cover article of Time magazine, Nov 2, 2020.

This Great Reset is a multi-billion/multi-trillion dollar global infrastructure that is being rolled out under the cover of the Covid-19 pandemic, and it will include a complete "knock down and rebuild" of the world's economy, together with a cashless society. This economic collapse and replacement will be blamed on the virus instead of the people who have mismanaged the world's finances for more than a century. As many people point out, this new economic system will eventually tie in with each individual requiring a biometric ID in order to access this digital currency and all services.

Bill Gates openly speaks about the need for all people to be vaccinated with an mRNA delivery system that will include a bioluminescent enzyme that will provide every citizen with a digital code accessed by every surveillance system throughout the earth, which will keep track of their vaccination and health record (**James Corbett Breaks Down the Great Reset #60**).

Dr Carrie Madej says, *"This is not just about power, it is about tyranny"* (**#61**). Dr Sherri Tenpenny says it is *"the biggest scam perpetrated on the human race"* (**#57.2**).

WHO: Mandatory Vaccinations for the Whole World by 2030

Never, before Covid-19, have all nations come together on an agreed course of action for the entire planet – remembering that Covid-19 is said to have provided a "unique opportunity" to reimagine our world, moving towards the Great Reset (New World Order). And part of that vision is the United Nation's Agenda 2030 (**#62**). This Agenda includes the World Health Organization's mandated vaccination program for all people on the planet by 2030.

But here is the problem. It is being marketed as a way to save lives, which would increase the world's population (#63.1). Whereas the UN's real agenda is in the opposite direction, in accordance with its Sustainability and Development goals. Remember, Bill Gates and other technocrats want to reduce the world's population by at least one billion people in order to "save the planet". And Gates has stated that if anything kills more than 10 million people it will most likely be microbes not missiles

(#63.2). He also says that we need to pair medical people with the military, taking advantage of the military's ability to move fast (#64).

After the US Government, Gates is the biggest financial contributor to the WHO. This gives him power and influence to control much of its agenda. It's also important to know that Gates is not the leader but a front man put into place by those engineering the New World Order (#65). As for the Director General of the WHO, Dr Tedros Adhanom Ghebreyesus, he was a former terrorist and is not a medical doctor, but was put into that position by the Bill & Melinda Gates Foundation, and the Clinton Foundation, and with the full support of the Communist Party of China, to execute their will. (Refer, Plandemic 2 Indoctrination.)

The New Normal Explained in Rockefeller Foundation Handbook

Only in light of everything else that is going on behind the scenes does the Covid-19 fear-mongering propaganda campaign and the rush to vaccinate everyone on the planet begin to make sense. It is all part of an unspoken agenda, orchestrated by the world's "super-class", to condition all people everywhere to passively accept the beginning of the "new normal", which will be anything but normal! (**How They Pulled off a Pandemic #66.**) Below are some quotes by Dr James Fetzer from Principia Scientific International. He writes:

"Years ago, Mike Adams, a food scientist, author and founder of ISO-accredited CWC Labs, warned: 'An engineered bioweapon will be released in population centres. There will be calls for massive government funding for the vaccine industry to come up with a vaccine. Miraculously they will have a vaccine developed in record time. Everyone will be required to line up and take this vaccine shot.' The rest of [Mike Adam's] message is that this vaccine will slowly begin to kill millions – if not billions – of people over the course of a few years. It will be a kill-switch vaccine, designed to reduce the world's population...

"The World Bank shows that COVID-19 is a project that is planned to continue until... end of March 2025! So the intention is to continue it for another FIVE YEARS. [Expected project closing date March 31, 2025].

"In 2010 the Rockefeller Foundation published the 'Scenario for the future...' in which they describe a coming global pandemic that should result in the implementation of authoritarian control over the people, which will then intensify after the pandemic. In 2020 they published a handbook on how to create this world of control, with a step by step guide. They say life cannot return back to normal, until the world has become 'Locked Down' with this top down control from authoritarian governments... When you combine the two Rockefeller documents, you will see the plan:

"First they announce a global pandemic with a coronavirus and say what it should lead to: a whole new level of authoritarian control. Secondly, they give practical steps on how to apply this control." (#67 article, #68.1 video).

When Dr Judy Mikovits was asked what would happen if Dr Fauci and Bill Gates managed to have Covid-19 mandated on a vaccine schedule in the US, she replied, "If they are successful in mandating it for everyone, at least 50 million Americans will die, probably from the first dose" (#68.2).

Dr Heinrich Fiechtner has echoed similar concerns. Dr Fiechtner is a member of the State Parliament in Baden-Württemberg. On December 30, 2020, he addressed the Chancellor and members in Federal Parliament slamming the government and media for their endless propaganda, disinformation and fake news concerning the coronavirus. He warned the public of the dire consequences of the new "killer vaccination" as he called it. He also gave

an impassioned speech on the floor of parliament about how Professor Uwe Janssens, President of German Interdisciplinary Intensive Care and Emergency Medicine, was claiming ICUs were overflowing with Covid-19 patients and could not cope. However, when Dr Fiechtner phoned the chief physician at one of these hospitals and asked how many Covid-19 patients they had in their 90-bed Covid-19 ward, *he was told there was not a single patient* (#68.3)! After two minutes, the President of the Bundestags told Dr Fiechtner to be silent as he had spoken too long.

Groundswell of People Pushing Back

Today, millions of people around the world recognise the scenario that is unfolding and they are speaking out and warning others. This is evidenced by the huge support shown to the filmmakers of *Plandemic 2 Indoctrination*, the American Frontline Doctors, and the millions of people who showed up at the protests organised by the German doctors in Berlin in August and October, as well as other demonstrations around the world (#69.1). Plus there are the multitudes who tune in to alternative and independent reporters and media hosts such as Brian Rose, Del Bigtree, James Corbett, Spiro Skouras, Derrick Broze, Sonia Poulton, Patrick Bet-David, David Martin, Whitney Webb, Dan Dicks, James Pilato, Celeste Solum, Ryan Cristian, Josh Sigurdson, and former mainstream award-winning investigative journalist Ben Swann, who has just launched his new decentralised news platform Truth in Media (<https://ise.media>) and there are many, many others.

This ability to report the truth is only possible by bypassing major Big Media and Big Tech organisations, owned by Big Pharma, which is owned by the global elite who are working to silence dissidents. And, as James Corbett at The Corbett Report warns, it is only a matter of time before Big Tech takes over or shuts down these platforms and servers, too, then all voices will be silenced, so now is the time to become informed before it is too late. And I just noticed something today, when logging onto the alternative video-sharing platform Bitchute. This is the first time I've seen this message:

"BitChute needs your help! We have been deplatformed by service providers and we are in the process of moving providers. If you experience an issue this is likely the cause. Please consider helping at this critical time."

Lawyers are raising their voices, too. One German lawyer addressing the coronavirus scandal and the defrauding of humanity is Dr Reiner Fuellmich. Incredibly, his video 'Crimes Against Humanity', is still up on YouTube, but not for long. **"We don't have a coronavirus pandemic, we have a PCR test pandemic"**, he says. Dr Fuellmich's primary work is fighting against corporate fraud (including Deutsche Bank and BMW). In a video he has stated that up to 800,000 small to medium businesses, which are the backbone of the German economy, are heading for bankruptcy. Other businesses that are facing bankruptcy, he says, are hospitals, which have been empty of patients for months now. And this is the tip of the iceberg of what is coming.

Dr Fuellmich explains how the definition of Pandemic was changed in 2008, from a disease that spread worldwide and led to many serious illnesses and deaths to a worldwide disease only (serious illness and deaths were no longer required). Due to this change in meaning, the WHO was able to declare the swine flu a pandemic in 2009. Swine flu vaccines were produced and sold out worldwide. However, they proved to be completely unnecessary because swine flu turned out to be a mild influenza. These vaccines led to serious health problems, with 700 children becoming permanently disabled with narcolepsy, so the vaccines were subsequently withdrawn and destroyed (#69.2). Going back further in time, in 1976 in the US, 46 million Americans took part in a swine flu immunisation program. Four thousand suffered neurological damage (#69.3).

In a 2010 article in Forbes magazine, 'Why the WHO Faked a Pandemic', the swine flu was called "one of the greatest medical scandals of the century". That fake pandemic deliberately misallocated \$1.8 billion dollars in terms of public health that was "motivated not by medical concerns but political ones... the WHO promulgated a new definition matched to swine flu that simply eliminated severity as a factor. You could now have a pandemic with zero deaths" (#70.1).

Covid "Cases" Found in Perfectly Healthy People

The horrendous state of the world in 2020, as it declines rapidly – *due to governments' policies of restrictions and lockdowns* – continues to be blamed on the Covid-19 pandemic. The solution? If we want to get back to "normal", they say, the world must be vaccinated, and since PCR testing for Covid-19 is losing credibility, a "new tool" is being deployed to keep the narrative going. That is, sewerage plants are now being investigated for coronavirus fragments so that "new clusters" can be found. This is even if no one in the area shows any sign of the virus.

In Australia, "Victorian health authorities are on high alert after coronavirus fragments were found in sewage in an area where there are no active cases" (#70.2). What is astounding is that most people don't have a problem accepting this when in reality it is utterly absurd. No one is sick from Covid and no one is dying, and no one has any symptoms, so why are the authorities on "high alert"?

It is important to remember that **even if the PCR test could reliably detect Covid-19 cases (which it can't according to its Nobel Prize winning inventor), the word "cases" does not mean people sick or dying of the virus.** It simply means damaged RNA has been detected in people and this can be the result of a number of health conditions, current or past. Besides, as we don't have an isolated purified specimen of the actual Covid-19 virus, all assumptions about that piece of RNA are null and void (#70.3).

As the Bakersfield doctors, Dr Dan Erickson and Dr Artin Massihi clearly explain, by quoting data and statistics: "More and more people are testing positive for Covid-19, yet the death rate is staying the same, which means, even fewer people with Covid-19 are dying than those with the regular flu. **So we see millions of cases of Covid-19 yet a small number of deaths**" (#70.4). These scientific facts, however, have not stopped the UK claiming that London has had a massive "surge of **cases**" as a result of people out doing their Christmas shopping. This stint of freedom, say authorities, "could lead to chaos" in the New Year and so Tier 3 restrictions were imposed on December 16th – all on account of 126,000 people being declared PCR Covid-19 "cases" in seven days (#70.5.1).

The continuous hyped up fearmongering is necessary, according to a growing number of doctors, journalists and others. Why? Because viruses that are highly fatal are not successfully transmissible as they kill too many of their hosts. Conversely, viruses that are highly transmissible are not typically fatal, because they are compatible with their hosts who spread it. So the globalists created the Covid-19, which is highly transmissible and not very fatal. Then they piggybacked the vaccine onto that, driving fear and medical terrorism to create demand for the vaccine by the people (#70.5.2).

In other words, the vaccine – not the virus – has always been the focus.

The Origin of the SARS-CoV-2 – Wuhan

Among others, activist Spiros Skouras believes the virus was created and then intentionally released at the World Military Wuhan Games in China in October 2019, where 110 nations took part, with 10,000 military athletes in attendance and around 230,000 volunteers recruited for the event. This suspicion is because many international athletes who attended the Games became ill with Covid-19 symptoms on their return home, having taken the virus around the world and thus sparking the pandemic (#70.6).

But even if Covid-19 did not produce the massive death count predicted, **there is evidence to suggest another pandemic is being planned**, as Bill and Melinda Gates have warned, with expressions that can only be described as positively gleeful: “We have to prepare for the next [pandemic]. *That one will* get attention this time” (#70.7). (Try playing this video muted to get the full effect of how happy this makes them.) This, of course, would serve two important purposes: 1) It would reduce the world’s population as has been the intention all along, including (particularly) those vaccinated; and 2) It would “prove” that the naysayers who outed Covid-19 fearmongering as a scam really are deluded “conspiracy theorists”, out of touch with reality and dangerous.

Another word about PCR testing. It is a process governments are using globally to obtain DNA profiles of all their citizens. The National Human Genome Research Institute calls it “DNA fingerprinting” (#70.8). Back in the UK in 2009, when DNA profiling was being carried out on people arrested for crimes (whether they were innocent or guilty) there was a huge outcry against this violation of human rights. Eventually the government backpedalled, claiming that genetic profiles of innocent people would be destroyed after 12 years. “Its move marked a minor climbdown, but will do little to allay fears that the rapid growth of the database is part of the remorseless expansion of the ‘surveillance state’.” Said Shami Chakrabarti, the director of Liberty: ‘...stockpiling the intimate profiles of millions of innocent people is an unnecessary recipe for error and abuse’” (#70.9).

Furthermore, according to former FEMA and Homeland Security contractor, Celeste Solum, who references military and government documents, PCR testing swabs deliver Hydrogel into the body which deploys nanoparticles to tag people. Her investigations have also shown that future government-issued face masks will also employ Hydrogel with the same purpose (#70.10).

World Economic Forum Warns of Coming Cyber Attack Crisis

And if for some reason the next Covid pandemic does *not* work to get everyone’s attention, the WEF is already warning of an even greater crisis – a large-scale cyberattack. This would take out the global information grid, resulting in the collapse of everything governed by power, e.g. computers, banking, all public services and all utilities, etc, which, among other things, would immediately effect transport, communications, hospitals, all businesses, law and order, food and water supplies and their storage, and sewerage plants. In other words, all the fundamental needs of our modern world could be shut down at the flick of a switch at any moment.

Just as the WEF, the Bill and Melinda Gates Foundation and John Hopkins University hosted their Event 201, in October 2019, which was a table-top exercise in how to handle a pandemic (handing out coronavirus plushies to those invited), the WEF also held a similar table-top exercise last year on cyberattacks. As **WEF Chairman Klaus Schwab** has warned/promised/predicted/threatened (?), a comprehensive cyberattack would cripple the world’s infrastructure and “**unleash a Dark Winter**” (his words).

The question is – are these tabletop exercises designed to prevent disaster and protect the public? Or are these “events” being scripted to unleash a pandemic, or take down the power grid and the financial institutions? After all, if the Covid-19 pandemic has been viewed as helping towards the acceleration of the Great Reset, as the WEF has alluded, could not a “cyber pandemic” also be considered a useful tool to speed things along (#70.11)?

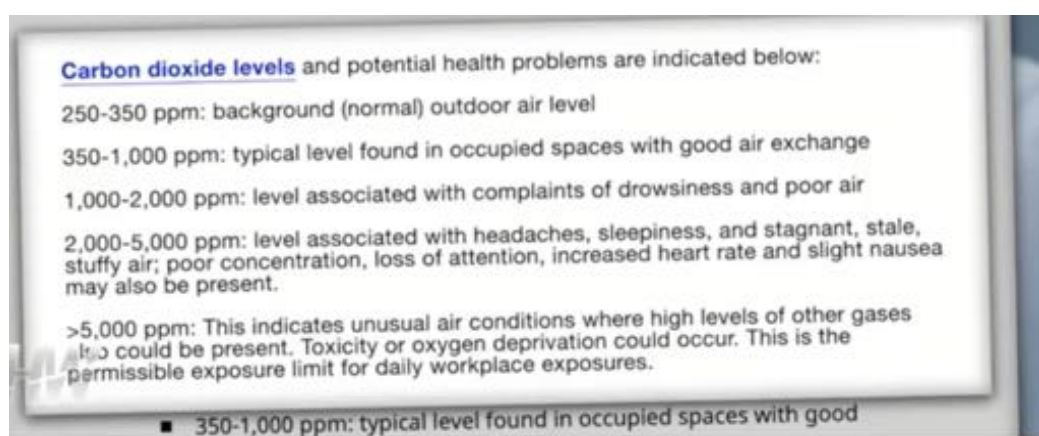
Children Sick and Dying from Wearing Face Masks

Regarding the subject of face masks, Dr Bodo Schiffmann, from the German Extra-parliamentary Coronavirus Investigation Committee is furious that a third child in one week has died from being forced to wear a face mask, one age six and two age 13. When Dr Schiffmann tried to conduct inquiries about these children, there was a cover up by the police and other authorities (#70.12). The

German doctors' Global Report also has accounts of children dying from wearing masks. An October 20, 2020, study into the effects of children wearing masks, conducted by the University of Witten in Germany, provides worrying statistics ([#70.13](#)).

Parents, doctors and teachers were asked to record their observations on an online registry. Six days later, data had been entered on 25,930 children. The average wearing time of the mask was 270 minutes per day. The results were published in Research Square. It states: Impairments caused by wearing the mask ... included irritability (60%), headache (53%), difficulty concentrating (50%), less happiness (49%), reluctance to go to school/kindergarten (44%), malaise (42%) impaired learning (38%) and drowsiness or fatigue (37%).

And no wonder. Del Bigtree from The Highwire tested a number of different masks on his 11-year-old son using an Occupational Safety Health Administration approved carbon dioxide metre (which registers ppm – part per million). See screengrab below for how toxic levels of CO₂ are determined:



The maximum range on the meter is four digits – 9999, after that the screen display goes blank. In only 20 seconds, the CO₂ toxicity inside the mask was off the scale. The **masks and bandanas** registered **9999ppm then the screen went blank**. This means they had more than **double** the permissible carbon dioxide exposure limit ([#70.14](#))!

Dr James Meehan, MD, wrote a risk analysis on mask wearing on the website GlobalResearch:

“Reports coming from my colleagues, all over the world, are suggesting that bacterial pneumonias are on the rise ... This is about politics and compliance, not science...” ([#71](#)). Many experts have explained that trying to prevent these miniscule viruses from travelling through a mask is the same as trying to stop a mosquito flying through a wire-mesh fence ([#72](#)).

Orthopaedic surgeon Dr Lee Merritt, speaking to a group of doctors at the America Frontline Doctors' White Coat Summit held in October, 2020, explains that medical masks are very useful when it comes to diseases such as TB and smallpox, which measure 3.0 microns and 2.0 microns respectively. However, **even the best face masks do not provide protection when it comes to tiny coronavirus/ influenza particles that measure a mere 0.12 microns**. Social distancing is also useless, as a virus can travel 30 metres. Dr Merritt drives her points home by showing a meme of a scientist encapsulated in a medical hazard suit conducting research in a lab. It reads, “This is what virologists wear to protect themselves from a virus, but don't worry ... your bandana or ear-loop mask works, too” ([#73.1](#)). America's Frontline Doctors Home page is a valuable resource (www.americafrontlinedoctors.com).

And here is a rather interesting – and sinister – observation by James Evan Pilato, host of Media Monarchy. Throughout history, masks have been used as a symbol of oppression and torture. Most recently, at the notorious **Guantánamo Bay detention camp in Cuba, where prisoners were forced to wear masks** – yet there was no virus and guards remained mask free. Today, Pilato and others believe masks have been weaponised to exert control and advance a political scamdemic ([#73.2](#)).

1000+ Scientists and Doctors Concerned About Electromagnetic Contamination of 5G

Here is possibly another part of the Covid-19 mystery, something else not being covered in the corporate media. In September 2017, 180 scientists from 36 countries called for a worldwide moratorium on the roll-out of the fifth generation 5G telecommunications network ([#74.1](#)).

This was because NO studies have ever been conducted to investigate the danger of this technology (which now blankets the entire globe) either on humanity or the environment. This 2017 moratorium followed 230 scientists from more than 40 nations who, only two years earlier, expressed their “serious concerns” about 5G, too, because EMF (electromagnetic frequencies) is toxic to living organisms ([#74.2](#)). This military-grade radiation, used in warfare, can cause DNA damage and neuropsychiatric effects and other major health problems (**What is 5G?** [#75](#); [#76](#)).

The reason I am mentioning this here is because a number of professionals have stated their concern that if a person is hit by a 60GHz frequency of 5G, (which can be directed at a very small target area) that person’s lungs will be severely affected and they will not be able to absorb enough oxygen to breathe. This can cause them to collapse on the spot and die. This, they say, is remarkably similar to the scenes the world saw in Wuhan, with people dropping dead in the street. It would also describe the weird symptoms, which, strangely, lasted only a few weeks at the outbreak of Covid-19, during which ER doctors in New York said they had never before seen symptoms like it.

Brooklyn ER physician Dr Kyle-Sidell said that these early Covid-19 patients did not present with typical Acute Respiratory Distress Syndrome (ARDS) symptoms. **These people did not have respiratory failure, they had oxygen failure.** That is why ventilators, which increased the pressure in their lungs, were killing them, because their muscles were working just fine. As such he said he did not believe these people had ARDS, but had something resembling high altitude sickness ([#77](#)).

A group of doctors in Denmark are taking legal action against their government over the installation of 5G. This group believes that 5G has been used, and could be used again, to induce the initial oxygen-failure Covid-19 symptoms to support and perpetuate the terrifying pandemic narrative. Doctors for the Truth in Spain have similar concerns, stating: “There are crossed toxic patterns. On the one hand, the electromagnetic contamination of 5G and on the other, the influence of influenza vaccination. There is an interaction and empowerment, which must be investigated” ([#78.1](#); [#4](#)).

Other doctors say the vaccines themselves could be used as a bioweapon to bring about another “wave” of the disease. That is, in the same way the vaccinated ferrets developed the wrong type of antibodies, which killed them when they came into contact with a wild coronavirus ([#48.5](#)). This scenario would “justify” the continuation of the Covid-19 pandemic narrative and also the “need” to continue with an aggressive worldwide vaccination program. This program, warns vaccine developer Dr Geert Vanden Bossche in an open letter to the WHO, **is a precursor to setting up a genuine deadly pandemic, by forcing an unnatural evolution of the virus with disastrous new variants and dire consequences.** Had it been allowed to run its natural course, he says, there would have been a spike of deaths in vulnerable people then the virus would have petered out ([#78.1.1](#)). There are also many reports coming in that people receiving Covid-19 vaccinations are testing positive for the virus only days later. This, vaccine manufacturers say, is not unexpected! Why? Because it is possible that the people had been Covid-19 positive **before** they were vaccinated ([#78.2](#); [#78.3](#)). In reality, it is far

more likely these people have contracted the disease from the vaccines that were supposed to have protected them. This happened with polio vaccines in India.

A 2018 article in the *International Journal of Environmental Research and Public Health* concluded that between 2000 and 2017 almost half a million children in India developed paralysis as a result of the Gates' supported polio vaccine. Using sleight of hand, the mainstream rushed to bury the story but thanks to the meticulous work of a team of Indian fact checkers – researchers and doctors – the document lives on the NIH National Library of Medicine website (#9.1).

Contracting a virus from the vaccine has also proved to be the case with the Covid vaccines. “On January 19, 2021, the Israeli newspaper Haaretz reported that **over 12,400 Israelis who had been vaccinated tested positive for Covid** – that’s 6.6% of the 189,000 vaccinated people!” (#78.3.1).

AstraZeneca Attempts to Sue Vaccine Injured Man for \$13 million

The refusal to accept any responsibility for Covid-19 vaccine injuries and shuffling the blame fits with the manufacturers' mantra that anyone who develops serious health conditions or dies not long after being vaccinated must have been sick *before* they were vaccinated. It is known that viral vector vaccines, such as AstraZeneca, can cause a negative immune response (#78.4). And when a 40-year-old Indian clinical trial participant developed acute neuroencephalopathy (brain damage) from the AstraZeneca vaccine, and sent a legal notice to the manufacturer, he received the reply that *they* were going to take legal action against *him* for maligning the company's reputation. They were claiming \$13 million in compensation (#28.1). **Which all goes to prove – these drugs are all about profit for these huge corporations and not about the welfare of the people who receive them.**

The argument that the vaccines could be used as a bioweapon to cause a devastating pandemic is explained by the German doctors in their Global Report. They explain the history of **the 1918 Spanish flu**, which was neither Spanish nor was it flu. Rather, it **was bacterial pneumonia caused by an experimental bacterial meningitis vaccine, manufactured by the Rockefeller Institute for Medical Research**. This was injected into soldiers in 1917 at a military base in Fort Riley, Kansas, in the US. These soldiers were then sent to Europe to fight in WWI and they spread the bacterial infection at every stop along the way. The Rockefeller Institute also sent its vaccines to other countries in Europe. This connection makes sense, because the highest number of deaths was recorded among healthy young men, and bacterial pneumonia mostly attacks young adults. Influenza, on the other hand, usually affects the young, elderly and immunocompromised. It is estimated that 500 million caught the Spanish flu and 50 million died from it (#1.2; p65).

God Warns of Extreme Wickedness in the Last Days

To be honest, none of this should surprise Christians. We know that the “god of this world” was a murderer and a liar from the beginning and his main weapon is to grow pride and division and to surreptitiously and deviously deceive people into accepting untruths in order to fulfil his plan to destroy man and the planet. “Woe to the inhabitants of the earth and the sea! For the devil has come down to you, having great wrath, because he knows that he has a short time” (Rev 12:12).

Of all people, Christians should be able to grasp the magnitude of what is going on behind the world scenes – soon to become evident to all. This is because God tells us that the devil is real, he is smart (Eze 28:14) and he has a diabolical plan for humanity, whom he hates. And the Bible tells us that when Christ returns to this earth it will be to a devastated and thoroughly evil-infested planet, and if he does not intervene at that point, “there would be no flesh saved” (Matt 24:22).

“The heart is deceitful above all things, and desperately wicked: who can know it?” (Jer 17:9)

“And He said, ‘What comes out of a man, that defiles a man. For from within, out of the heart of men, proceed evil thoughts, adulteries, fornications, murders...” (Mark 7:21-22)

“But know this, that in the last days perilous times will come: For men will be lovers of themselves, lovers of money, boasters, proud, blasphemers, disobedient to parents, unthankful, unholy, unloving, unforgiving, slanderers, without self-control, brutal, despisers of good, traitors, headstrong, haughty, lovers of pleasure rather than lovers of God...” (2 Tim 3:1-4)

“The Lord saw that the wickedness of man was great in the earth, and that every intention of the thoughts of his heart was only evil continually. And the LORD was sorry that He had made man on the earth, and He was grieved in His heart. So the LORD said, ‘I will destroy man whom I have created from the face of the earth, both man and beast, creeping thing and birds of the air, for I am sorry that I have made them’” (Gen 6:5-7).

“But as the days of Noah were, so also will the coming of the Son of Man be” (Matt 24:37).

Where Experimental Gene Therapy is Heading

King David worshipped the Lord with the words: “I will praise You, for I am fearfully and wonderfully made; Marvellous are Your works, And that my soul knows very well” (Ps 139:14). And Paul tells us that our body is “the temple of the Holy Spirit” (1 Cor 6:19-20). **Yet Dr Fauci, Bill Gates and the most powerful and wealthiest people on the planet want us to believe that the human body cannot survive in this world unless it is vaccinated against Covid-19 – with a drug designed to mess with the genetic code our Creator designed for us.** (New mRNA and DNA genetically modifying vaccines are being hailed as quick-response technology that will potentially replace traditional vaccine delivery systems.)

Not only that, but Big Pharma and governments are telling us that the entire human race will need to be continually vaccinated against Covid-19, every year, because it is never going to go away! And even if we are vaccinated, said Dr Fauci in February, 2021, people should still not eat out, go to movies or congregate with others. Furthermore, masks will still need to be worn and social distancing should continue (#78.5). On top of all of this, financial, media and software company Bloomberg has done the math and has reported that Covid-19 will not, apparently, be going anywhere for at least another seven years (#78.6)!

None of which makes any sense in light of true science, but then nothing about Covid-19 makes any sense, according to the narrative that has been spoon fed to the public (#24.3).

Dr Carrie Madej explains what is up ahead for Moderna’s mRNA vaccine technology. It will have a microneedle platform (also known as quantum dot tags) developed by the Massachusetts Institute of Technology. This has tiny needles designed after a viper fang. These needles use **TRANSFECTION** technology, which injects a **genetically modified piece of** RNA coding of the virus directly into the host RNA, which then multiplies. Transfection is the same gene technology that is used to genetically modify animals and crops. The next part of the delivery system is a **LUCIFERase** enzyme, named because it has bioluminescent qualities that show up under the skin when scanned. It will also use **HYDROGEL** containing microscopic robot-like nanoparticles developed by DARPA (which is a research and development agency under the control of the US Department of Defence).

This biological nanotechnology will connect to our SMART devices, so we can all check on our blood pressure, nutrients, blood sugar and oxygen levels, etc. (Something else God did not, apparently, consider when He created us.) Oh yes, and it will also be used to integrate every person into a global surveillance network of artificial intelligence, which will be used to track every person on the planet

in real time. This, we are told, will be for our good, to notify us if we have been in contact with anyone carrying a deadly virus. This is the goal, as Bill Gates himself says.

Dr Madej explains that this process of genetically modifying human beings will be a form of transhumanism, as it melds the human body with AI. (Warning, this video has some confronting images of genetically modified babies, #61). I have also included another link with Dr Madej's explanation on this subject. This video is particularly interesting because it shows the two great deceptions taking place, side by side. The creator of this website 'Stop World Control', David Sorenson, talks about the censorship of doctors and scientists around the world. He then features Dr Madej who describes in detail how the world's population will be controlled through this new vaccine technology and its connection to the military and governments (#78.7).

Man, by Himself, will Conquer Evil?

When looking into the philosophical worldview of David Sorenson, it is of particular note that he is a Christian who has dedicated his life to helping others. He even pioneered a church. **But here is where things get weird – his focus is not Jesus Christ, it is about man's ability to find his own freedom from within!** In other words, his worldview/faith is established (unknowingly) on the second great deception that is emerging, soon to take centre stage, as I explain in Parts 7 & 8 of this document.

With regard to world control that is starting to be enforced through governments with a "health" agenda, check out James Corbett's documentaries **Medical Martial Law** (#79.1).

In closing this chapter: Elon Musk has spoken often about the breakthroughs on the medical front by using synthetic mRNA vaccine technology. "You can basically do anything with synthetic RNA and DNA. It is like a computer program... you could probably stop or reverse the ageing process. You can turn someone into a freaking butterfly if you want, if you have the right DNA sequence" (#79.2).

CHAPTER 6: DANGEROUS DRUGS – WHY THIS DISREGARD FOR HUMAN LIFE?

The Arrival of Rockefeller Medicine in the Mid-1800s

The most difficult part in all of this is understanding why anyone would have such a disregard for human life that they would want to engineer the injury and death of millions or even billions of people? It just does not make sense to the average person. That is why this next part of the puzzle is crucial, for without it there is no overarching context or motive. In short, it is a spiritual matter, with its roots in the demonic ideology of the eugenics movement and man's desire to exalt himself to god status wielding power and control over other human beings he considers "undesirables".

Oil magnate John D Rockefeller and steel magnate Andrew Carnegie played pivotal roles in the 19th century American eugenics movement (as does the Rockefeller dynasty today). In the early 20th century, eugenics programs led to more than 60,000 Americans, mainly women, to be coercively sterilised. Victims were systematically tricked into thinking it was a harmless procedure. Rockefeller and Carnegie also funded the worst Nazi doctors and race institutions. **After eugenics was attributed to Hitler's Nazi experiments, it needed rebranding; it was renamed genetics (#80.1).**

In James Corbett's documentary Rockefeller Medicine, he explores the history of modern medicine. This is important, as it provides the foundation for what we are seeing today. That is, the global drive by Big Pharma and health organisations to mandate a Covid-19 vaccination program for all people on the planet. Corbett explains that in the 1860s, patients had a choice of treatments for ill health. The first was **homeopathic medicine**, which used herbs and diet that took the whole body into consideration. This was founded on empirical science (testing, observing and verifying treatments), which had been handed down for millennia. These holistic doctors were called empiricists.

Alternatively, a patient could choose **allopathic medicine** (using drugs to treat or suppress specific symptoms and surgical intervention). Allopathic medicine was founded on remedies that produced effects different from or incompatible to the disease being treated. JD Rockefeller realised that the heavy use of drugs leads to other health problems that required even more drugs. In 1901, John D. established the Rockefeller Institute for Medical Research. Both **Rockefeller and Carnegie sensed a goldmine in modern allopathic medicine and they literally took over the medical schools and allopathic medicine by funding them and promoting their new health system (#80.2.1)**. These teaching institutions removed any mention of the healing power of herbs or natural treatments in their curricula. Teachings on diet and other natural (non-drug) treatments were also completely removed from medical programs.

The Rockefellers Own All the Pharmaceutical Companies in the World

These men made sure to skew medical schools towards the petrochemical-based pharmaceuticals they developed. They called this philanthropy and "donated" millions of dollars for research and training. The Rockefeller Foundation transformed the practice of medicine at the beginning of the 20th century and pharmaceuticals became the treatment of "choice". **To understand our current healthcare system, says Corbett, we need to understand it was laid out generations ago by people with foresight and malice.** A powerful book that exposed the Rockefeller and Carnegie cartel behind this was written by E C Mullins 'Murder by Injection' (1988).

Ultimately, these wealthy and powerful men wanted to control the whole cycle of people's lives – from birth to death.

As for the empiricists, they were driven out of their profession by being excluded from medical schools and universities. They were also ridiculed as quacks and lost their medical licences. Thus

Rockefeller's modern medicine was born and spread across the globe to become known in recent times as Big Pharma. **Today, the Rockefellers own all the pharmaceutical companies in the world.**

Corbett continues: Profit, however, has not been their only goal. They have always had a much deeper agenda. These people wanted to wield their power over mankind for a specific purpose – to set in place their eugenics program for depopulation. This began in earnest when John D Rockefeller III, grandson of oil baron John D Rockefeller, visited Dhaka, Bangladesh. On seeing it swarming with people living in crowded, squalid and smelly conditions, he remarked to his companion, “Well, that’s the problem, isn’t it?” **And “armed with the unimaginable wealth, power and influence that his family name bestowed on him, he was on a mission to do something about the ‘problem’ of overpopulation.”**

He began by founding the organisation Population Council in 1952 and served as the organisation’s first president. The Population Council supported medical and scientific research into finding a “solution” for the growing human population. Fredrick Osborn became the Population Council’s next president in 1957. He was a founding member of the American Eugenics Society. In 1968 he wrote, **“Eugenicist goals are most likely to be attained under a name other than eugenics.”** (#28.1).

Corbett concludes: **“Modern medicine is not 100% evil; it would be cartoonish to believe that. But it is the poison pill they can insert into all of this to achieve what they set out to achieve”** (**Rockefeller Medicine** #80.3.1). Of particular note: Bill Gates’ father, William H Gates, was a technocrat, eugenicists and had deep ties with the Rockefellers (#80.3.2).

AstraZeneca’s Eugenics Connections

An example of the potential evil designs behind some of these vaccines is the Oxford-AstraZeneca vaccine, which will be the vaccine of choice for the developing world on a non-for-profit basis. This is being marketed as an act of philanthropy. *But what pharmaceutical company has ever been motivated by altruism?* Let us take a closer look at what is going on here.

“The developers of the Oxford-AstraZeneca Covid-19 vaccine have previously undisclosed ties to the re-named British Eugenics Society as well as other Eugenics-linked institutions like the Wellcome Trust”. (The British Eugenics Society is now called the Galton Institute, after the ‘father of eugenics’ Francis Galton.) This vaccine is destined for “countries in Latin America, South and Southeast Asia and Africa, the very areas where the Galton Institute’s past members have called for reducing population growth.”

David Galton, emeritus professor of molecular genetics at the Galton Institute, has written that the Human Genome Mapping Project had “enormously increased . . . the scope for eugenics . . . because of the development of a very powerful technology for the manipulation of DNA” (#28.1).

Catherine Austin Fitts is the president of Solari Inc and publisher of the Solari Report. She describes how eugenic technocrats view everyone else. It is not that they hate humanity but they hold them in utter disdain, viewing them as natural resources to be used for profit. **This is because the elite have literally broken away from the rest of humanity (culturally, legally, financially) and created a separate civilisation for themselves.** They do not consider the human race as being the same species as they are but as livestock – a commodity. That is why they can commit mass murder without feeling any guilt or remorse (#80.4).

Says Mike Adams, “The globalists have been convinced that the planetary eco system is about to reach a tipping point, in which there will be a self-reinforcing spiral of destruction leading to

ecological collapse. And that if they do not take drastic measures to eliminate millions of people, the planet will be destroyed” (#47.5).

Eugenics Ideology Explains Population Reduction Goal

It is important to know that those behind the WEF’s drive to transform the global health care industry also have their roots in the 19th and 20th century eugenics movement, the goal of which has always been to lower the world’s population: for example, the **Population Council** (founded and funded by the Rockefellers), **Planned Parenthood** and the UN’s **Agenda 21** environmental movement, euphemistically termed “sustainability development goals”. As one news report states:

“Like its founder [J D Rockefeller III], the Population Council’s other members were concerned about population issues — and, like other population organizations such as Planned Parenthood, high ranking Population Council leaders were well connected to the eugenics movement... According to author Edwin Black, ‘In 1952, at a secret, invitation-only gathering in Colonial Williamsburg, John D. Rockefeller III brought together what would become the modern population control establishment’.” The article explains that at one point, the Population Council published that **it may be necessary to contaminate urban water supplies with “fertility control agents”**. The Council is “credited” with bringing the abortion pill (RU-486) to the US (#80.5)

Edwin Black writes: “Eugenics would have been so much bizarre parlour talk had it not been for extensive financing by corporate philanthropies, specifically the Carnegie Institution, the Rockefeller Foundation and the Harriman railroad fortune. They were all in league with some of America’s most respected scientists hailing from such prestigious universities as Stanford, Yale, Harvard, and Princeton. These academicians espoused race theory and race science, and then faked and twisted data to serve eugenics’ racist aims... **The Rockefeller Foundation helped found the German eugenics program and even funded the program that Josef Mengele worked in before he went to Auschwitz**” (#80.5; #81).

These people have such disdain for the masses of humanity “beneath” them that they are on a mission to barcode all life on the planet. This is being accomplished through the Rockefeller organisation **International Barcode of life: Illuminate Diversity (IBOL)**, and CBOL – the **Consortium of the Barcode of Life**. CBOL has more than 130 member organisations from around 40 countries, one being the National Institute of Health in the US, another being IBM, which supported the Holocaust. IBM had a 12 year alliance with the Third Reich (#70.10). CBOL’s plan is found in the **Manual on Procedures For Disease Eradication by Stamping Out**. It explains how to dispose of different animals. Indirectly this includes humans, because a committee spent 10 years to reclassify all life forms for a project called the **PhyloCode**.

The outcome was that human beings were reclassified as phyla, which means people have been put into the same category as dinosaurs, arthropods and birds. The **Barcode of Life Data System (BOLD System)** is an informatics workbench aiding the acquisition, storage, analysis and publication of DNA barcode records. Genetically modifying plants and animals was the first stage in the plan to genetically modify all life – including humans. Today, there are human genes in rice, potatoes and other vegetables.

The Power Behind the WEF, UN and WHO

The World Economic Forum, which is in partnership with the United Nations, gets to set the international agenda and programs according to its [eugenics] worldview. These people do not achieve this through any particular organisation but through their monopolisation and consolidations and connections to the most powerful organisations on earth. All of which provide a backdoor into every nation’s government to influence their policies. Politicians are either

blackmailed, bribed, lack courage or are ignorant about what is going on with regard to Covid-19. And when a politician does question their government, such as Australian Federal MP Craig Kelly recently, they are soon reined in, ridiculed in the media and their Facebook posts deleted. (Freedom of speech, even among politicians, has been shown to be rapidly disappearing.)

And the big question is: can we trust those who hold the highest positions of power in the world in organisations such as in the WEF, the UN and the WHO? All of which receive vast funding from shadowy “philanthropic” foundations and wealthy individuals and corporations. What are the interests of these people at the top of the human hierarchy (ruled by the god of this world)? And do their concerns about an “overpopulated planet” far outweigh the concerns for its people?

It is crucial to understand that **the spirituality of the UN and its affiliated organisations is occult to the core** (#82, be sure to scroll to the bottom of the page).

World Speeding Towards a Totalitarian Government

God could, of course, step in anytime to slow things down, if he chooses, according to his sovereign plan, but our evil worldly system, as it stands today, has progressed too far to be reversible. No US president, for example, has the power to take on the Deep State and the elite. If they tried, they would, in effect, be signing their own death certificate.

This is not about a lonely individual walking the streets with a sandwich board declaring, “The end of the world is nigh”. It is about millions of people (communicating online) from all countries and all walks of life and from different faiths and ideologies who agree that the future of the human race is poised on the edge of an abyss. Their fear is not about Covid-19. It is about the world moving at breakneck speed towards implementing a technocratic state – a New World Order; the Great Reset; the New Normal – where the “globalists”, “oligarchs”, “technocrats”, “super-class”, whatever we call them, are only a few short years away from fulfilling their long-term goal of centralised control over the entire planet and everyone in it, with the eugenics agenda to reduce the world’s population.

David Icke calls these people “the elite”. Robert F Kennedy Jr describes the soon-coming global totalitarian state as a plutocracy. The dictionary meaning of which is, “those who form a government in which all power is vested in a few persons or in a dominant class or clique”. These elite/oligarchs are now only a few years away from fulfilling their goal, which is centralised control over the entire planet and everyone in it, with the agenda to drastically reduce the world’s population.

This is all being accelerated under the cover of a regular flu season and being attributed to a fake Covid-19 “pandemic”. And, according to Bill and Melinda Gates, the next [engineered] pandemic (which may indeed prove serious this time around) has already been forecast/scheduled (#70.7).

Journalist Spiro Skouras explains how the Great Reset “solution” to the world’s problems is being achieved using the Hegelian dialectic philosophy of Problem – Reaction – Solution. The (engineered) **problem** is Covid-19; the **reaction** is to wipe out the middle class and instigate a controlled demolition of the world economy. This brings about the **solution** – justification for the Great Reset. In the media, we are being lied to. If we want to get back to normal, they say, we will all need to be vaccinated. Whereas in reality the powers-that-be have no intentions to get us back to normal, at all. In the words of Klaus Schwab, the Founder and Executive Director of the WEF, it is now time for one unitary power to enforce order on our post-Covid-19 world.

“The Covid-19 crisis has shown us that the old world systems are not fit anymore for the 21st century... Now is the historical moment to shape the system for the post-corona era... In short, we need a Great Reset... A return to business as usual [won’t] happen because it can’t happen. For the

most part 'business as usual' died from (or at the very least was infected by) COVID-19... **If no one power can enforce order, our world will suffer from a 'global order deficit'” (Your Guide to the Great Reset, #83.1, #83.2).**

The Great Reset's Version of Equality – Own Nothing and be Happy!

Putting together the Great Reset and the Covid-19 engineered “crisis”, it is clear the elite are in the process of bankrupting the governments and people of the world – *so they can rebuild it according to their version of “equality”*. That is, wipe out the middle class to make everyone equally poor and dependant on the government. Then reintroduce the medieval two-class system: the elite and the workers. Writes David Malpass, President of the World Bank: (emphasis added)

“Debt restructurings need to reduce the amount owed and should be reached with less litigation and more transparency regarding their terms. By taking swift, broad, and forward-looking action, the G-20 nations can help people in poverty-stricken countries break out of the devastating economic cycle that sovereign debt crises bring” (#83.3).

And how are they going to do that? Dr Rashid Buttar reads a leaked Covid-19 document that had been secretly obtained from a committee member of the ruling Liberal Party of Canada (and particularly from the Strategic Planning Committee). It lays out the Canadian Government's plan for 2021, in terms of the Covid-19 “crisis” and the projected collapse of the Canadian economy – *and a way to help people stricken with devastating debt. Although 30% of the committee members did not agree with the plan, they were told it will go ahead no matter who opposes it.*

In short, the government will implement more lockdowns, build isolation facilities across every province and territory, predict a new pandemic (which, many believe will be a manmade pandemic with a vastly higher mortality rate), enforce more restrictions, warn of food and other supply chain breakdowns, plan military intervention, and will transition the public into a World Debt Reset program that will erase all their debts *and take possession of their property*. The people will then have to rely on the government for every aspect of their lives. This is enforced Communism. It will also include mandatory vaccinations if people want a health pass to move freely in public. Those who refuse to comply will eventually be sent to internment camps. If Canada fulfills this plan, people warn, it may well become the road map for the rest of the world (#83.4; #83.5).

What is being proclaimed here fits with what the Bible warns will happen in the last days, described as “a time of trouble, such as never was since there was a nation even to that time” (Dan 12:1).

And here is breaking news in Australia (January 2021). The biggest change since Federation, in defence and security, is taking place as parliament is about to pass legislation that will give the Australian military and foreign powers the right to act with force and aggression, within the borders and homes of Australian people, and with immunity from criminal or civil liability, in all cases when performing their duties (#83.6). **In other words, it will soon be legal for Australian and foreign militaries to act against the Australian people without any liability for their actions.**

Goal of the Fourth Industrial Revolution – “Human Enhancement”

The World Economic Forum is part of an historic movement that has been around for almost 100 years. According to James Corbett (refer #83.1, Your Guide to the Great Reset), the Bilderbergers and the Trilateral Commission (founded by the Rockefellers) are at the top of the globalist enterprise pyramid and the WEF is a little lower down. Today, the WEF and its partner organisations are about to achieve their long-time goal of worldwide centralised control by *transforming the world* according to their Great Reset. (Keep in mind that the word ‘Transformation’ is a buzzword in their New World Order vocabulary.) Dr Mercola presents the same information –Big

Pharma has been planning the transfer of wealth from the lower and middle class to the technocrats for more than 100 years. He refers to a number of authors who have documented how this is being achieved. The Trilateral Commission and the Council for Foreign Relations being at the heart of this agenda (#83.7).

This powerful “super-class” collective transcends national boundaries and owns most of the world’s wealth. They work to shape governmental policies globally and are on the threshold of implementing what they term “the Fourth Industrial Revolution”. That is, they plan to take slow and “purposeless evolution” into their own hands to manipulate and accelerate the advancement of a certain class of individuals, through gene technology and artificial intelligence, in their quest for ultimate power and control over all humanity. Their ultimate goal is to achieve physical immortality.

Below is a quote from an article on the WEF’s website describing the **Fourth Industrial Revolution**: ‘Where Will Evolution Take Us in the Fourth Industrial Revolution?’ – emphases added.

“People have always wondered whether evolution is constantly driving onwards and upwards. Is there always going to be improvement? *The answer is no—evolution is a progression of form and function, but it is not purposeful...* In the Fourth Industrial Revolution, ‘satisfactory’ may no longer be the status quo. We are now witnessing the most revolutionary stage of evolution, *when we give up evolving by biology alone*. With new life sciences tools such as CRISPR-Cas9 gene editing, we are now able to reshape genomes and alter biological form and function. The quest for human perfection through gene editing has already begun.... *The potential to accelerate and direct the course of biological evolution raises further questions, the most urgent of which is how to manage collateral changes to the environment*” (#84).

Here is a 2.20 min video posted on Twitter by investigative journalist and activist Spiro Skouras (#85). It shows how the WEF’s Fourth Industrial Revolution is all about totalitarianism and transhumanism. But in case that video gets deleted, here is the full 22 min program (**The Global Reset and the Fourth Industrial Revolution** #86).

Two “Man is God” Philosophies Emerging

The goal of these elites (presumably the most highly evolved of all of us) is to “transform” every aspect of our lives, *including a transformation of what it means to be human*. Why? Because the idea our bodies are natural, they say, must change. They reject slow “purposeless evolution” and are working to replace it with accelerated *purposeful* evolution. This, of course, will play out on two distinct levels – that of the elite and then everyone else, in a two-caste system. For the majority of mankind on the lower level, the technocratic elite have no conscience about genetically modifying these people globally, through their dangerous, experimental and ongoing Covid-19 gene therapy programs. As for the multitudes who will die along the way, it is a matter of survival of the fittest.

At the upper level (the elite), the “transformation” or “acceleration of human evolution” – through “transhumanism” and “human enhancement” – is all about *attaining perfection*. This provides these people with a philosophical framework to justify the melding of humans with artificial intelligence (falsely marketed to the public as biomedical interventions to benefit all humankind). Such a farsighted vision, however, presents its own set of problems. As the WEF’s article explains, it raises the urgent question of “*how to manage collateral changes to the [new transhumanist] environment.*” That is, how they can save/keep the earth’s resources for themselves, which, of course, explains their depopulation agenda for everyone else.

Unsurprisingly, the WEF's agenda for **Gene Technology** and **Human Enhancement** is mirrored on the Eugenics Movement website listed as **New Genetics** and **Transhumanism**. In fact, if you click on Transhumanism, it leads directly to Human Enhancement (#87). Forbes magazine calls the Human Enhancement Agenda 2030 'Human Augmentation' (#88.1). There is no doubt our world is at the door of the devil's endgame, as a relatively small number of elitists behind the scenes gain more control while viewing the rest of humanity as a cancer that is of necessity disposable (i.e. "useless eaters").

As Dr Sherri Tenpenny exclaimed, "If people could take a 30,000-foot view to see where this is all going, this is America's [the world's] last hurrah" (#57.2)!

CHAPTER 7: BIBLE PROPHECY DOES NOT ALIGN WITH TRANSHUMAN AGENDA

A Second Deception Set to Dominate the World

So far, musing on all that is happening in the world has left out one CRUCIAL point. The WEF, UN, WHO, Trilateral Commission, Bilderberger Group and any other powerful organisation are NOT *really* in control on this earth. The devil is, as he manipulates the members of these and other bodies through his human agents/spiritual advisors (occultists) to bring about his earthly purposes. All of which, of course, is being allowed to take place under the sovereign rule of our Almighty Creator God (Ps 22:28) for His heavenly purposes “to bring many sons to glory” (Heb 2:10). And right now, the devil is pulling the strings of TWO great deceptions, which appear to be pitted against each other, in order to position humanity where he wants them – and God is allowing it, for a time!

This double deception is apparent when we look at Bible prophecy, because it does not describe the end time as a world inhabited by atheistic transhumans. (Transhumanism being part of the WEF and eugenics movement agenda.) Rather, it will be a world spiritually united in worshipping the devil and his human representative (i.e. the dragon and the beast of Rev 13:2-4). No wonder Jesus warned his people the end time would be defined by deception and that it would come upon them so quickly and stealthily many Christians would be caught sleeping and unprepared (Matt 24:3-4; Matt 25:1-13). To them, the time of Christ’s return would be like a thief in the night (1 Thess 5:1-5).

And so on one hand (from the top down), there are the technocratic elite developing their Fourth Industrial Revolution. This they see as the [biotech] *scientific* vehicle needed to enhance and accelerate the “evolutionary process” to establish their immortality – *in effect, attaining “god status” by their own power*. Meanwhile, they do not plan to take the vast majority of humanity, who they see as competing for the planet’s resources, along with them.

Remember, **those at the top of the power pyramid are there because of their involvement in secret societies, which have evolved from mystery religions and occult practices, and communications with ‘channelled’ demonic entities.** To understand the Luciferian power play behind the world scenes, check out this excellent video on the history of the Illuminati (**#88.2**). This is where they get their “inspiration” and “power” from (Eph 6:11-12). Also refer to the Georgia Guidestones, believed to be of Rosicrucian origins: “Maintain humanity under 500,000,000 in perpetual balance with nature. Be not a cancer on this earth ... Leave room for nature. Leave room for nature” (**#89; #90**).

On the other hand (from the ground up) there is a growing grassroots *spiritual movement*, generated by the same demonic entities but operating from a different platform. These people are pushing back against the agenda of the elite. This mystical emerging spirituality became apparent to me when I realised a large number of the most vocal opponents to the imminent Great Reset (the “new normal”), although not Christians, still hold great hope for the future. While unmasking and condemning the technocratic agenda, they still speak of the Covid-19 pandemic as being “a wonderful opportunity ... the turning point for humanity”. (Check out 2.10 hours into this video of Brian Rose interviewing David Icke, **#91**.)

Mikki Willis, filmmaker of Plandemic 2 Indoctrination, also holds this view. At the end of his film, which uncovers the economic agenda behind the false Covid-19 pandemic manufactured to cripple this world’s economic systems, he declares: “The good news is, our story is not over. The climax has yet to come. That moment when the hero rises to their feet summoning a force they forgot they had. A force within, a force of nature”. The German doctors explain it this way. “We do not want the

old normal, or the new normal, we are looking to a *better* normal". And there are many other examples of this great positivity ("when light will overcome darkness") against a backdrop of impending doom (without them knowing the God of the Bible). But what did this mean?

The Rise of the New Age

It was then I realised, these people have a New Age worldview, or at least they are open to the perception of a spiritual dimension in the physical realm. They are certainly searching for something to give them hope in the face of despair. Many of these folks are extremely likeable, charismatic, and their values often reflect godly principles. Their concern for humanity is admirable so is their passion to want to fix the world's problems. However, as I have come to learn on closer examination, **their positive worldview has been shaped by the same lie the devil told Eve in the Garden – once people recognise their divine spark, the god within, they will finally be set free.**

As for Christians who refuse to be part of this global New Age oneness, they will represent the separateness of the old world and all its evils and the time will come when that will not be tolerated. And so these new agers believe that out of the dark, dystopian nightmare about to engulf humanity, a new world will arise, a better world – not through the God of the Bible, but through us realising "who we really are" in our "evolutionary journey" – "infinite beings with infinite consciousness", as Londonreal.tv host Brian Rose summarised to David Icke.

New Age philosophy is another manifestation of the idea man can become his own deity!

Thus, we have come full circle, from the Garden of Eden to the end of time and back again, when the devil defied the all-powerful Creator God and tempted the first man and woman away from Him, seducing them with the lie that they, too, could be god: "and you will be like God" (Gen 3:5).

"Super-class" and New Agers – Each Looking for World Transformation

In one Zoom video, "Christian" evangelist Dr Aaron Lewis says of fellow zoomer and the star of Plandemic 2 Indoctrination, Dr David Martin, "[He] has a god status in line with what is happening on a spiritual plane". This **Plandemic 2 Zoom (#92)** is a powerful example of this rising grassroots New Age spirituality. This movement is based on the belief that a New Age for humanity is finally dawning, in which all people can evolve in personal spiritual self-development. It is significant that the term "world transformation" features prominently not just in the technocrats' Great Reset but also in the glossary of terms of its opponents – the New Age movement.

"New Age practitioners hope to save the world one individual at a time... This gradual approach represents the movement's vision for world transformation" (**#93**).

This New Age vs. Great Reset battle of ideologies shows how they really are different forms of the same lie – evolution, and that man can attain god status (one way or another). One way is through the occult branch of "evolutionary science/philosophy", which various Christian creation ministries have been exposing for decades. The other way is through the pagan branch of "Eastern spirituality", which Christian discernment ministries have been unmasking, also for decades (since the 1980s).

Here is a brief history of the New Age. The world's occult mystery religions (and secret societies) gave birth to the Theosophical Society (founded in New York in 1875), which in turn gave birth to the New Age movement in the West in the mid-20th century. Thirty-two-degree Co-Mason and theosophist Alice B Bailey (1880-1949) was a prolific writer of occultism. Her esoteric teachings form the foundational literature of the New Age movement and are the spiritual heart of the UN. **Bailey is considered the matriarch of the New Age.** This movement grew in popularity among hippies in the West during the 1960s, who embraced Transcendental Meditation and other Eastern practices. It

was further promoted by the occult teachings of David Spangler in the 1970s. Today, New Age customs and practices saturate the Western world in multiple forms (e.g. yoga, meditation, Reiki, crystal healing, Tarot cards, astral travelling, drumming, astrology, reincarnation, dream catchers, visualisation, psychic healing, power of positive thinking psychology, the New Thought philosophy of the law of attraction, etc).

Without wanting to give the devil too much credit, what is playing out on the world scene really is an ingenious ideological/spiritual deception that has been crafted to ensnare *every individual on the planet*, from the lowest to the highest and from every faith and belief system. As stated above, such an end-time scenario is being worked out, by devilish design, using **Hegelian dialectic philosophy**: the globalist technocrats (**thesis**/problem) opposed by the new agers (**antithesis**/reaction), resulting in a totalitarian one-world government driving the New Age spirituality (**synthesis**/solution).

And I cannot help but be reminded of a very knowledgeable and discerning evangelist 10 years ago who constantly reiterated his belief, and warned believers, that Hegelian dialectic philosophy would be the vehicle to bring about the events written about in the Bible describing the last days.

But God's power and brilliance rules supreme and if we pray to him for guidance, his Holy Spirit will give us the ability to discern and escape this deception (Luke 21:35-36). Here is an old (2011) but excellent video describing the New Age and its occult connections and agenda – **The New Age and Its Relationship to the Antichrist** (#94).

Wake-up Call to Christians

Since the 1980s, New Age customs have been infiltrating churches everywhere: e.g. walking prayer labyrinths, spiritual formation, "Christian" yoga and "Christian" meditation, breath prayers, contemplative spirituality, centering prayer, entering the silence, etc. (Check out New Age discernment ministry Lighthouse Trails Research, #95.1.) According to the Pew Research Center (2018), 60% of Christians have adopted elements of this Eastern smorgasbord of beliefs and practices into their lives. The Bible calls this being "filled with Eastern ways" and offering "strange fire", a form of syncretism God hates (Is 2:6; Lev 10:1; Rev 2:12-17). Not only that but "Christian" mystics abound in our world today as both religious leaders and teachers. Their books are filling the shelves of Christian bookshops and even many true believers are eagerly snapping them up, hoping to uncover mysteries and add spiritual experiences to their lives.

However, when a person (even a Christian) enters into any form of mysticism, they enter into the realm of the occult. And the Holy Spirit will not share a realm that God has declared to be "an abomination unto the Lord" (Deut 18:12).

In Lighthouse Trails December 9, 2020, newsletter is an article, '2020 *The Secret: Dare to Dream* Movie Rekindles 2006 Occultic Message'. The writer explains that with so much dislocation in society at this time, the New Age "law of attraction" philosophy and message of this movie – the belief that your thoughts and words dictate what you will get or what will happen in your life – is sure to resonate with millions of Christians who are involved in the contemplative movement. **These Christians have been trained in New Age concepts and practices for years without recognising their occultic origin.** The writer states:

"With the church's fascination and embracing of meditation through the contemplative prayer movement (ie. spiritual formation), the film further gives the green light to millions of Christians to be ushered deeper into mysticism" (#95.2).

In contrast, when King David meditated he never emptied his mind to enter "the silence", applying visualisation techniques to go into a trance-like state to receive visions from "God". Rather, he

meditated on God's precepts, commandments, statutes and laws (Ps 119). That is, *he was not looking for a "spiritual" experience, but rather to fill his mind with the words of God.*

I have experienced, firsthand, being part of a church that turned to mysticism, which was under the guise of intellectualism rather than experiential. It began subtle and was cleverly implemented over many years. Thus it took a long time for me to work out what was happening and to eventually leave that church. It even taught that all humanity now exists within God (pagan panentheism) and thus is, effectively, God! This, however, was always obfuscated – never spelt out in words or terms the congregation could understand. Nevertheless, many believers who think they are discerning dismiss mystical teachings or practices as not being problematic in their church environment.

Considering all these things, I believe that from all the chaos about to appear on the world scene through the plans of the global elite, a devilish (and seductive) form of mystical spirituality will arise. This will morph into great signs and wonders so powerful **Jesus warned they will even seduce many compromised believers**, followed by a great falling away from the faith by those who will go along with it. Furthermore, it will be a time when Christian brother will deliver Christian brother over to death thinking they are doing it for God (2 Thess 2:1-12; Matt 24:10, 24; Mark 13:12).

In other words, there are two opposing deceptions manifesting in the world, each leadership group operating from the platform of evolutionism and each with its own view of a distinct, but opposite, process transforming humans into gods. And believers need to be aware of both.

Dawning of the "Age of Enlightenment" in 2025?

The technocrats have set their *material* goals for Agenda 2030 and Agenda 2050 and they plan to reach these milestones and keep going with their Great Reset. New agers, on the other hand, are setting purely *spiritual* goals. People who have left the occult/New Age to embrace Christianity would be familiar with my following references to occult literature. I have some understanding from reading about their experiences in their autobiographies. I don't think new agers speak yet of a specific timeframe when the whole world will "evolve to godhood", but the occult certainly does.

Alice B Bailey, under the guidance of her spirit guide (demon) Djwhal Khul, wrote 24 books. She taught that significant events would be taking place leading up to 2025. This is because **2025 is the 150th anniversary of the founding of the Theosophical Society** in New York (in 1875). Bailey writes:

"Thus a great and new movement is proceeding and a tremendously increased interplay and interaction is taking place. **This will go on until A.D. 2025.** During the years intervening between now and then very great changes will be seen taking place, and at the great General Assembly of the Hierarchy [demonic gathering]—held as usual every century—in **2025 the date in all probability will be set for the first stage of the externalisation of the Hierarchy [and the reappearance of the Christ]**" (#95.3). (Bailey's work was originally published in 1922 by Lucifer Publishing, but under pressure she changed the publisher's name to Lucis Trust two years later.)

The "externalisation of the Hierarchy" is the occult's description of powerful, visual manifestations from the fallen spirit world set to emerge in the lead up to the last days, which may include the "reappearance of the [false] Christ". This, of course, would fit with God's explanation of this time, in 2 Thess 2:1-12, although God's timing is clearly not subject to the plans of the devil.

Global Totalitarianism to Merge with a One-World Religion

Considering all these things, I believe the devil is using the elite to set up the mechanism for a global totalitarian state (the Great Reset) in preparation for the one-world religion (although these people may not realise this). Concurrently, the devil is directing new agers to reject the Great Reset by

meditating against it for world peace. In New Age spirituality, if people empty their minds and become the centre of love and kindness at the same time, it is believed a nucleus of love and kindness will form in the world. And the more people who join, the more that nucleus will grow until it fills the whole earth. This belief is expressed both overtly and subtly.

Here is a subtle example of how this is playing out: By February 25, 2021, 50% of Israel's population (which totals almost 9 million people) had been vaccinated with the first dose of the Pfizer coronavirus vaccine, while 35.2% have received the second dose (#95.4). Clearly, the Jewish people are not stupid, so what has happened here? Why are they being so compliant with the vaccine program? This mystified me. **The Israeli government, I learned, had made secret deals with Pfizer, to swap 40 years of meticulous, digitised medical records of the Israeli population for vaccines.** The government has also lied to the people telling them the vaccine is completely safe (#95.5.1).

Authorities now require all their citizens to have a Green Passport in order to access services, but it is only available to those who have been vaccinated. Those unvaccinated can also be publicly named and shamed. What is happening in Israel (and Canada) is the roadmap for the rest of the world. They are creating a medical apartheid leading to medical martial law (#78.1). Only snippets of information are getting out of Israel but they are grim (#95.5.1.1). For example, an Israeli woman speaks of a Covid-19 human rights group that became a political party in the Knesset in less than a month, but they have been censored and attacked, and can get no media coverage. The authorities took away the medical license of the head of the party and removed their Facebook platform (#95.5.1.2). Also, a group of Israeli lawyers, physicians, activists and members of the public have written to the International Criminal Court in The Hague complaining about 'Violation of the Nuremberg Code by the Government of Israel and Additional Factors' (#95.5.1.3).

Many people are already dying from the vaccines in Israel. Medical statistics show the mortality is 40 times higher since vaccinations began eight weeks ago, with more deaths attributed to the vaccines than the coronavirus. Nevertheless, these official statistics, as documented in Medics Debate, are not being reported in the news anywhere (#95.5.2). Millions in Israel are now refusing the vaccine, but without a Green Passport they cannot participate in public life (#95.6). They cannot visit friends, go to school, work, the shops, restaurants, gym, movies, etc. Then a few days ago, I discovered a video by a Jewish man living in Israel. He is urging the world to wake up, rise up and stop the gross violations of human rights taking away the individual's freedom to make choices about their own health. This is not just Israel, he warns, it will affect the whole world (#96.0). Surprisingly, however, this man inexplicably brightened up at the end of his video message. Why? Because he is compelled to believe there is hope, *somehow*. **"If we think positive thoughts, we CAN turn this world around. If we rise up, speak out and think positive, amazing things WILL happen!"**

But this belief – that (sinful) man doesn't need God, just the power of his own thoughts – is the greatest deception of all, and it IS leading somewhere very specific, in relation to end time events. The New Age calls it "the law of attraction". It is the belief that if the spirit inhabiting every person unites in positivity, collectively this will lead to world peace. This is the spirit of antichrist – the demonic end-time deception behind the New Age world peace movement (unwittingly embraced by millions globally). In truth, however, the more people who voluntarily link positively in a spiritual manner (ultimately through mystical New Age/occult meditation) the more power is given to Satan.

500 million Connect Spiritually for World Peace Day

Since its beginnings in the 1960s, the New Age "world peace movement" has been growing and by 1986 it had taken control of the minds of half a billion people (for a short time). This is an example of things to come.

“Since 1986, December 31 is **World Peace Meditation Day**. On December 31, 1986, over 500 million people of all religious faiths in over 70 countries joined their minds in peace, love, forgiveness and understanding. The event is still going on, for one hour starting at noon Greenwich Mean Time, with groups gathering in all U.S. states and around the world. ...this simultaneous global linking of minds takes as its basis the principle of fuzzy quantum physics musing that thought can direct energy, creating reality. Meditating on peace can create peace. ... To maximize the collective impact of the loving kindness meditation, individuals meditate at specific times and places” (#96.1).

In this way, unknowingly, “all who dwell on the earth shall worship [the dragon]” (Rev 13:4, 8).

Today, many World Peace groups exist. One is the Global Meditation Movement. Its website states their Principles as: Smile; Trust Life; No Forcing; Act with Love; Just be Positive; Speak Truth; **Believe in your Self; Everyone is a Master**; Everything is Possible”(#96.1.1) “Masters” in the New Age are spiritually enlightened humans who can be transformed/evolve into immortal Ascended Masters on a higher spiritual plane. Exactly how these two groups – the Technocrats and the new agers – will synthesise into one body is anyone’s guess at this point in time. But here is my theory.

The Last 150 Years – the Time of the End

The Bible warns that evil will escalate as the return of Christ grows nearer, because Satan knows his time is short (refer Matt 24 and Revelation). God tells us it will be like the days of Noah – when evil increased so, too, did the preaching of the Word of God go out to the people as a warning (Heb 11:7; 2 Pet 2:5). Then the flood came and took them away.

Jesus’ end time prophetic warning was that nation would rise against nation and there would be famine, pestilence and earthquakes in various places, but these would be only the beginning of sorrows. And if we take a 30,000 foot view of recent history we see this escalation of evil on a global scale is exactly what has happened.

Starting in the mid-19th century, Darwinism and the birth of the modern eugenics movement, which was founded in the US in 1883 by Sir Francis Galton, arose and gained momentum. This movement popularised a scientific “solution” to improve the genetic quality of the human population excluding those who were considered “inferior”. Sir Francis Galton and Charles Darwin shared Darwinian agnosticism and antagonism to Christianity (#96.1.2). Also, by 1897 occultism was well established in the West with almost 30 per cent of the men in the United States belonging to secret societies (occult organisations). This was a time when wealth was being accumulated and managed on an unfathomable scale by a select few people on the planet (the elite), through their monopoly over the oil, steel, pharmaceutical, military weaponry and other global industries.

Today the elite also have control of Big Tech and Big Media and a back door into the governments of the world, essential for driving their propaganda machine and eugenics agenda (#96.1.3). As James Corbett keeps reminding us, the eugenics movement has a long history and it did not go away after WWII, it just changed its name. (Refer to this link to find dozens of articles and podcasts on this subject <https://www.corbettreport.com/page/2/?s=eugenics>. But just as in Noah’s day evil parallels goodness, because with the explosion of the devil’s work over the last 150 years, through occult organisations and the escalation of evil, so too has there been an explosion of God’s Word – all over the earth. **“And this gospel of the kingdom will be preached in all the world as a witness to all the nations, and then the end will come”** (Matt 24:14). Christian missionaries have been around since the beginning of the church, but if we look at the late 18th

century and on into the 20th century, multitudes of missionary societies were established and thousands upon thousands of missionaries went out to every part of the globe. Truly the gospel of the kingdom was sent into all nations! **When God deems that work finished – the end will come!**

How the Elite and the New Agers Could Merge into a Global Body

Understanding the roots of our modern history, it becomes apparent. The Spanish flu pandemic (the outcome of Rockefeller's 1918 bacterial pneumonia vaccine; #1.2, page 65), along with World Wars 1 & 2, Communist takeovers, nationwide famines and other disastrous events over the last 100 years or so, which have killed hundreds of millions of people, were not random, manmade or natural disasters. They were meticulously planned and orchestrated by a small number of wealthy and influential people, under the power/instructions of the god of this world. Most often, no one knew who the human instigators and executives were who operated the vast bureaucracies underpinning these events. And when Nazism and Communism, for example, collapsed, only a few of those responsible were ever held accountable for their crimes against humanity. Others were whisked away to South America or other places to secretly start a new life.

The faceless elite at the top of this power pyramid, who engineered these atrocities, however, still remain anonymous to us today.

If this is a template for what is coming, it would make complete sense to believe the following. Millions/billions of people will die in the coming years from disease and famine (and possibly wars or acts of terror) and a one-world government, with a powerful surveillance grid, will take centre stage.

However, right on its heels will be the opposing New Age movement, preaching the need for mankind to unify, spiritually and globally, in order to topple the oligarchs and their agenda to control the world. The power of the new agers will be greatly strengthened by spiritual manifestations – the externalisation of the Hierarchy (a devilish delusion, sent by God). **This could provide the seismic shift in world perceptions and events that will merge the two groups** (2 Thess 2:9-11; Rev 13:15).

A few of the elite will be caught and killed to appease the masses, but the others (nameless and faceless) will simply and anonymously “disappear into the woodwork”. They will remain hidden in society. No doubt, these elite will then become the new officials tasked with the administration and implementation of the New World Order bureaucracy. The only difference now being that a counterfeit spirit of “love and unity” will have been introduced into the totalitarian system.

This, I believe, is a very likely scenario – in which the devil can merge his one-world government with his one-world religion.

New Ager Instructs How to Avoid Armageddon

Ultimately, the New Age deception will emerge as the most deadly. This is because it will culminate in the whole world joining together in an ecumenical, inter-faith religion that will worship the devil and give allegiance to his human agents – the beast and the false prophet (#96.2). Those involved will experience a euphoric spiritual sense of “oneness”, a counterfeit perception of godly love, when they all link together meditating “on the god within” (Rev 13:11-18; Is 42:8).

“New agers believe that the world is poised to explode into a New Age of enlightenment. They are convinced that this ‘**new world order**’ **will be united under a one world government and initiated by a quantum leap in humanity’s spiritual evolution.** New agers believe that we are all one with each other and the universe [an Eastern pantheistic concept]. We are all connected by the common chord of the cosmos” (#96.3).

New Age leader Barbara Marx Hubbard was a prominent occultist until her death in 2019. Through her spirit guide “Christ” she spoke of how mankind could avoid Armageddon and evolve to godhood, by linking spiritually. Remember her “God” and “Christ” are imposters, demons (original emphasis).

“Armageddon is, dearly beloved, the dreadful script which you and I rewrite now ... You are to prepare the way for the alternative to Armageddon, which is the Planetary Pentecost, the great Instant of Cooperation which can transform enough, en masse, to avoid the necessity of the seventh seal being broken ... Tell them to recognise the God within themselves, and to follow that light through the darkness of the tribulations to the dawn of the Universal Age ... All those sealed with the seal of the living God must be consciously linked in a common thought pattern for an instant in time to AVOID ARMAGEDDON. The bell will never toll, if you can link before the end must come. I cannot ‘return’ until enough of you are attracted and linked... **After the selection process, you will be born to the next stage of evolution.**” (*The Revelation: A Message Of Hope For The New Millennium*, 1995)

Those who do not comply are said to be “self-centered” and holding up the evolutionary process for everyone else, so they must be removed like a life-endangering cancer. “The fundamental regression is self-centeredness, or the illusion that you are separate from God. I ‘make war’ on self-centeredness. It shall surely be overcome. At the co-creative stage of evolution, one self-centred soul is like a lethal cancer cell in its body, deadly to itself and to the whole ...” (*Ibid*)

When will the Great Tribulation Begin?

From my understanding at this time, the Great Tribulation will begin when we see the “abomination and the desolation” – when Jerusalem is surrounded by armies and the Great Babylonian (interfaith/ecumenical/New Age) religion is established in the Holy Land. Then, in a spirit of unity, all the people on earth will worship the image of the beast on account of supernatural events (Rev 13:15).

“And forces shall be mustered by him, and they shall defile the sanctuary fortress; then they shall take away the daily sacrifices, and place there the **abomination of desolation**. Those who do wickedly against the covenant he shall corrupt with flattery; **but the people who know their God shall be strong, and carry out great exploits. And those of the people who understand shall instruct many**; yet for many days they shall fall by sword and flame, by captivity and plundering.” (Dan 11:31-33).

This prophecy in the Book of Daniel was originally fulfilled in 175BC when the new ruler of the Hellenistic Seleucid Empire, Antiochus Epiphanes, set up a statue of Zeus in the Holy of Holies and stopped animal sacrifices. He also offered a pig on the altar in a deliberate attempt to desecrate and render it unholy for Jewish worship. When Jesus prophesied to his disciples, he spoke of a similar event that would occur at the end time that would signify the beginning of the Great Tribulation.

“So when you see the ‘**abomination of desolation,**’ spoken of by Daniel the prophet, standing where it **ought not** (let the reader understand), then let those who are in Judea flee to the mountains. For in those days there will be tribulation, such as has not been since the beginning of the creation which God created until this time, nor ever shall be. And unless the Lord had shortened those days, no flesh would be saved; but for the elect’s sake, whom He chose, He shortened the days” (Mark 13:14, 19-20).

God Tells Us to Separate – Not Unite

The New Age “solution” is for the world to unite as one. God’s instruction to us is the diametric opposite – for us to separate from the world!

“Therefore ‘Come out from among them And be separate, says the Lord. Do not touch what is unclean, And I will receive you.’” (2 Cor 6:17).

God is the only source of truth not us and unless we believe this and hold firmly to his Word – the Holy Bible – he warns that *we will be deceived*.

“The coming of the lawless one is according to the working of Satan, with all power, signs, and lying wonders, and with all unrighteous deception among those who perish, because they did not receive the love of the truth, that they might be saved. And for this reason God will send them strong delusion, that they should believe the lie, that they all may be condemned who did not believe the truth but had pleasure in unrighteousness” (2 Thess 2:9-12).

It is God who determines when our time on the earth is ended. Said the prophet Job: “Since his days *are* determined, The number of his months *is* with You; You have appointed his limits, so that he cannot pass” (Job 14:5). As the Great Tribulation draws near, God may protect individuals or he may not. But he promises to guide and give strength to all who turn to him and remain in him. **Our place of safety is in Jesus Christ.** Trust in him whatever happens and our reward will be eternal life.

“Do not fear any of those things which you are about to suffer. Indeed, the devil is about to throw some of you into prison, that you may be tested, and you will have tribulation ten days. **Be faithful until death, and I will give you the crown of life.**” (Rev 2:10)

“His lord said to him, ‘Well done, good and faithful servant; you were faithful over a few things, I will make you ruler over many things. Enter into the joy of your lord’ (Matt 25:21).

CHAPTER 8: THE SEASON OF THE ANTICHRIST AND THE MARK OF THE BEAST

Quantum Mechanics – Down the Occult Science Rabbit Hole

Some people have pointed out that quantum computing may have a part to play in uniting of man and machine in the future. However, there is still considerable doubt, in some quarters, whether quantum computers can produce meaningful results based on the fundamental probability element of quantum theory. As the computing power of the latest computers continue to increase strongly, this could mean that the planned global surveillance system will not have to wait for the quantum computer in order to approach real-time surveillance capabilities.

Providing some background on the possibilities of quantum computing, and the part it may play in the end time, is author, speaker and researcher Anthony Patch. Patch speaks of the secretive data-analytics company **Palantir** that is developing the **Tiberius** quantum computing software program. This will be used to track the manufacture, distribution and administration of Covid-19 vaccines. This program was named after Star Trek's Captain James **Tiberius** Kirk. **Operation Warp Speed**, which is a public-private partnership initiated by the US government, has been set up to accelerate the process. (The occult are known to use esoteric names, terms and symbols to describe their operations.) Palantir is also one of the world's largest surveillance companies in the world.

According to Patch, "We are in the season of the antichrist". He explains that the Tiberius quantum computing is an occult science, because it identifies patterns in hidden information (forbidden knowledge) to prognosticate and predict the future (divination). It is a form of mystical science that leads a person along a certain path, which opens up a perception of a different reality.

Scientists describe quantum mechanics as a *strange and counterintuitive world*. Unlike Newton's empirical science, **quantum mechanics is an abstruse system of analytics used to discover golden nuggets of small data string patterns hidden within Big Data streamed over the internet-of-things and thus seems to take on a clairvoyant nature**. Subject examples are, breaking news, census data, economic indicators, climatic events, opinion polls, major events and military intelligence that facilitate strategic planning in combat, economics, politics, and shifts in trends and other issues. **This strange and counterintuitive technology is being used by the US Defence Department and Homeland Security.**

Interestingly, as Patch has pointed out, Tiberius is also the middle name of Augustus **Tiberius** Caesar – who was alive at the time of Jesus Christ. Some believe this to be significant, as Tiberias' quantum computing involvement in the end time-scenario may coincide with the arrival of the antichrist (#96.4). They also believe the projected Covid-19 microneedle (quantum dot tag/patch) vaccine technology, which will deliver semiconductors and other DNA modifiers into the human body, will "marry" a person, technologically and mentally, to the occultic Tiberius software, in some way changing the human mind. In this way, some have speculated, vaccines could lead to **the mark of the beast**.

Although this might sound like science fiction, the technology is already scientific fact, as we read in a John Rice University press release, 'Quantum-dot tattoos hold vaccination record' (#96.5).

"The tags are incorporated in only some of the array of sugar-based microneedles on a patch. When the needles dissolve in about two minutes, they deliver the vaccine and leave the patterns of tag just under the skin, where they become something like a barcode tattoo."

This technology dovetails into the International Barcode of Life (IBOL) mission, to have all life barcoded and entered into the Barcode of Life Data System (BOLDS). Although we don't know what

role quantum computing will play in the end-time scenario (other than the promised computing super speed of it), this occult science is yet another way human beings might be manipulated by the god of this world. Says Dr Johan Denis of Belgium: “There is nanotechnology present in this [mRNA] vaccine. Nanobots in hydrogels have been developed for military purposes. **There are strong indications it could make you a controllable puppet by means of your own smartphone connected with the 5G network and artificial intelligence**” (#96.6).

Make no mistake about it, we are entering the deadliest time in the history of humanity.

Christians – the Only People with Real Hope

The reality is that we are powerless to do anything about the events that are unfolding before us. However, as Christians we have access to the greatest power of all, our Lord, Saviour and Creator God, who has promised to never leave us nor forsake us. Jesus tells His people, “You do not belong to this world, but I have chosen you out of this world” (John 15:19).

Although the world is about to descend into great darkness, there really IS good news on the horizon. It cannot be long before our Lord and Saviour will soon return with the armies of heaven to rid the world of evil.

“Then the LORD will go forth And fight against those nations, As He fights in the day of battle. And in that day His feet will stand on the Mount of Olives ... And the LORD shall be king over all the earth: in that day shall there be one LORD, and his name one” (Zech 14:3-4,9).

Bible-believing Christians have genuine hope, because we are under no illusion. We know who we are – created out of the dust of the ground in the image of our Maker (Gen 2:7; Gen 1:27). **And we know why we were born – to be children of the living God for His great and loving purpose** (John 1:12-13). Also, we are to share with others the “good news” (gospel) of Jesus’ sacrifice, in which he voluntarily laid down his life to pay the price for all the sins of the world. Thus he paved the way for all people to be reconciled to their Creator – through God’s grace and mercy, and his forgiveness upon our belief and repentance (1 Cor 15:1-4; Mark 1:15).

The good news of the kingdom of God, as proclaimed by Jesus, has begun. It started as small as a mustard seed at Jesus’ first coming and with the gift of the Holy Spirit to those who believed, repented and were baptised (Matt 12:28; Acts 2:36-38). These people are no longer trapped by the lies of the god of this world but have become a new creation – new citizens subject to a new administration under the King (John 17:14; 2 Cor 5:17; Rev 15:3; Eph 2:19). Furthermore, this kingdom will grow when Jesus returns until it covers all the earth. “Then the seventh angel blew his trumpet, and there were loud voices in heaven, saying, ‘The kingdom of the world has become the kingdom of our Lord and of his Christ, and he shall reign forever and ever’” (Rev 11:15).

And the best thing is we know how it will ultimately turn out – with the end of all sin, pain, suffering and tears to be replaced with joy unimaginable (Rev 21-22). In the meantime, our current world situation is a serious wake up call for all people everywhere to turn to the one true God, who created heaven and earth and all things in them. Also, for all of God’s people to deepen their relationship with him by learning to love him and trust him more and more every day, as the evil in this world intensifies.

When Jesus’ disciples asked what would be the sign of the end, He said, “**Take heed no man deceives you**” and “For then there will be great tribulation, such as has not been since the beginning of the world until this time, no, nor ever shall be” (Matt 24:4, 21). He also questioned if he would find faith on the earth when he returned (Luke 18:8). And I cannot stop thinking of the central

importance of faith and truth in our lives. I believe we need to be aware of the uncertainty and perils ahead in preparation to make decisions based on truth, love and wisdom and not on the lies fed to us by the god of this world and his human agents.

I also believe our trust in God will soon be tested beyond anything we have ever experienced – but our reward will be beyond measure (Jer 29:11; Rom 8:18-25).

The Truth About Sustainability Development

Before closing, I want to comment on the UN's 2030 Agenda for Sustainable Development (i.e. population control measures). According to the UN, the WEF and other such bodies, the planet is overpopulated and there is not enough food nor resources to go around. This is their "justification" to establish a global totalitarian state by the year 2030, with, as Bill Gates has stated, an engineered lowering of the population through vaccination programs. This overpopulation premise, however, is not based on truth. There are 7.5 billion people on earth and 510 trillion square metres of land on the planet. And according to the Huffington Post, the world already produces enough food to feed 10 billion people. The problem is how that land and food are being mismanaged (#97).

More importantly, God commanded man to multiply over the face of the earth and He has provided enough resources to sustain everyone. He has also provided us with bodies that are miraculously designed to fight diseases without the help of Big Pharma (if we follow the principles of healthy living).

This means the reason given to justify the Great Reset masterplan for all humanity is based on a lie!

All the systems in the world have either been inspired, constructed, manipulated or infiltrated to some degree by the god of this world. As such, none can be trusted totally. That is why Christ will return to destroy this evil world and all its systems, bind the devil and establish His kingdom rule on earth – based on God's righteousness and justice, love and mercy and truth (Rev 19:11-21; 20:1-6).

"Righteousness and justice are the foundation of Your throne; Mercy and truth go before Your face. Blessed are the people who know the joyful sound! They walk, O LORD, in the light of Your countenance. In Your name they rejoice all day long, And in Your righteousness they are exalted." (Psa 89:14-16)

God's Response to Wickedness

So far, this document has dealt with two great deceptions – the evil clandestine plans of the elite and the enticing and seductive spirituality of the New Age. In finishing, I will now draw attention to two more crucial parts to this puzzle – the increasing wickedness pervading our modern world, and how God is going to deal with it. God is gracious, forgiving, compassionate, long suffering, and abounding in mercy, truth and goodness (Ex 34:6; Ps 86:15), but **God cannot be loving unless He is also righteous. Otherwise He would accommodate evil and injustice, which is not loving.**

Throughout the history of the world, there have been times when God has intervened to destroy people and nations because the level of wickedness, which increases suffering, has become intolerable to him. The first major example was in the days of Noah:

"Then the LORD saw that the wickedness of man was great in the earth, and that every intent of the thoughts of his heart was only evil continually. And the LORD was sorry that He had made man on the earth, and He was grieved in His heart. So the LORD said, 'I will destroy man whom I have created from the face of the earth, both man and beast, creeping thing and birds of the air, for I am sorry that I have made them.'" (Gen 5:5-7)

God also brought destruction on the nations of Israel and Judah. When God called the prophet Jeremiah to warn the nation of Judah to turn from her sinful ways and repent, or the whole land would be laid desolate, Jeremiah could not understand why God would threaten to harm His people. Jeremiah pleaded with God to relent, even after God had declared, "O Jerusalem, wash your heart from wickedness, that you may be saved. How long shall your evil thoughts lodge within you" (Jer 4:14). How could the Lord use the nation of Babylon, reasoned Jeremiah, that was far more evil than Judah, to kill and enslave His people? Slowly, however, the prophet's eyes were opened to see the extent of the people's wickedness – then he knew. There could be no recovery for the nation: there is no balm in Gilead; there was no physician to heal her evil ways (Jer 8:22).

Another prophet who had to have his eyes opened was Ezekiel. The Lord took Ezekiel by the spirit into Jerusalem to see the bloodshed and perversions committed by the House of Israel. So great was their iniquity, Ezekiel watched on as God sent six angels to slay all the people in the city who did not "sigh and cry over the abominations done within it" (Eze 8:16-18; Eze 9).

God's Coming Judgment – then World Peace!

Surely it is the same with us today. We know bad things are happening around us, but how many of us have any idea of the scope of evil taking place in our own nation, particularly at the highest level in the land? That is why I have included links to these two shocking videos ([#98](#); [#99](#)). This documentary and interview with investigative journalist and filmmaker Sonia Poulton exposes a network of the most abhorrent sin imaginable throughout the British parliamentary establishment, and this is not peculiar to the UK, as author Joachim Hagopian has written about extensively. Unconscionable evil (along with blackmail) has escalated around the globe over the last 50 years, among politicians, royalty and other dignitaries. Why else would governments everywhere be willing to crash their economies on account of mysterious advisors in response to a virus that is mostly found in faulty PCR testing and sewerage plants?

The engineered destruction of the world's economies and the enslavement of its people is being orchestrated by the god of this world. But it is our Almighty Creator God who has declared that this world is coming to an end. "I *am* the Lord, that *is* My name; And My glory I will not give to another..." (Is 42:8). "No one calls for justice, Nor does any plead for truth. They trust in empty words and speak lies; They conceive evil and bring forth iniquity" (Is 59:4). "At that time Michael shall stand up, The great prince who stands watch over the sons of your people; And there shall be a time of trouble, Such as never was since there was a nation, Even to that time. And at that time your people shall be delivered, Everyone who is found written in the book. And many of those who sleep in the dust of the earth shall awake, Some to everlasting life, Some to shame and everlasting contempt." (Dan 12:1-2)

Being aware of the evil state of our world in these last days provides us with a much deeper understanding, not just about WHAT is happening but also WHY it is happening, WHO is really in control, and HOW it will end!

"Behold, He is coming with clouds, and every eye will see Him, even they who pierced Him. And all the tribes of the earth will mourn because of Him. Even so, Amen." (Rev 1:7)

“And behold, I am coming quickly, and My reward is with Me, to give to every one according to his work.” (Rev 22:12)

Unparalleled sorrow is at the door, but God assures us the wicked will be judged and peace and joy will follow. First with the return of Christ, defeating the enemy and ushering in 1000 years of peace on the earth (Rev 20). After this when the new heaven and new earth replace the old, and the new Jerusalem comes down from heaven “and God shall wipe away all tears from their eyes; and there shall be no more death, neither sorrow, nor crying, neither shall there be any more pain: for the former things are passed away.” (Rev 21:1-4).

In the meantime, there is an antidote for the burden that comes with all this knowledge of where the world is heading: praise God, just as King David did in every dark situation he found himself. This is because when we honour God we focus on who he is, what he has done for us and his awe-inspiring promises for where he is taking us – into a glorious eternity with him.

“Yours, O LORD, is the greatness, The power and the glory, The victory and the majesty; For all that is in heaven and in earth is Yours; Yours is the kingdom, O LORD, And You are exalted as head over all. Both riches and honour come from You, And You reign over all. In Your hand is power and might; In Your hand it is to make great And to give strength to all. Now therefore, our God, We thank You And praise Your glorious name.” (1 Chron 29:11-13)

Jesus Christ’s Glorious Promises to Those Who Overcome

“To him who overcomes I will give to eat from the tree of life, which is in the midst of the Paradise of God... He who overcomes shall not be hurt by the second death... To him who overcomes I will give some of the hidden manna to eat. And I will give him a white stone, and on the stone a new name written which no one knows except him who receives it... And he who overcomes, and keeps My works until the end, to him I will give power over the nations...

“He who overcomes shall be clothed in white garments, and I will not blot out his name from the Book of Life; but I will confess his name before My Father and before His angels... He who overcomes, I will make him a pillar in the temple of My God, and he shall go out no more. I will write on him the name of My God and the name of the city of My God, the New Jerusalem, which comes down out of heaven from My God. And I will write on him My new name ...

This video is a 1970s presentation by Corrie Ten Boom. Corrie (1892-1983) was a Dutch Christian who, along with her family, was sent to a Nazi concentration camp for hiding Jewish people in her home during WW2. In this video, Corrie talks powerfully about how she could feel the presence of God's love even in the darkest places and the most hopeless situations. Surely this is a great encouragement for us today, as perilous times and persecution will soon be upon many of us, too.

"God does not have problems, he has plans. God's love stands when all else has fallen!" Corrie Ten Boom.

The Voice of the Martyrs was founded by Richard Wurmbrand, a persecution Christian who took the gospel message to Communist Russians and German Nazis at the beginning of WW2 as these people arrived in his native Romania. He was arrested and sent to prison for 14 years, much of which was spent in solitary confinement where he was brutally tortured for his faith. He never stopped witnessing for Christ.

Eventually he was released and in 1969 he began the ministry Voice of the Martyrs (VOM), which has been committed to serving other persecuted Christians around the world ever since. Today, VOM is operating in 68 dangerous countries.

In this presentation, three former prisoners of faith tell their testimonies – Petr Jasek, Dan Baumann and Andrew Brunson. These are ordinary people who struggled and failed at times, but through Christ they became overcomers and an inspiration to other believers. As Petr Jasek says, "Even if we don't know where God is taking us, we need to trust and lean into the leadership of Jesus Christ, and follow".
